- 31 (4) RESTITUTION OF ALL MONEY TAKEN FROM OR PAID BY THE

- 1 PERSON AFTER A JUDGMENT WAS OBTAINED BY A CREDITOR;
- 2 (5) PUNITIVE DAMAGES;
- 3 (6) ATTORNEY'S FEES; AND
- 4 (7) ANY OTHER RELIEF THAT THE COURT CONSIDERS PROPER.
- (B) IN ADDITION TO ANY JUDGMENT UNDER SUBSECTION (A) OF THIS SECTION, IF A CREDITOR OR COUNSEL REPRESENTING A CREDITOR WILLFULLY FILED AN AFFIDAVIT REQUIRED UNDER THIS SUBTITLE CONTAINING FALSE INFORMATION, THE COURT MAY AWARD TREBLE ACTUAL DAMAGES TO THE PERSON IN AN AMOUNT NOT LESS THAN \$1,500 PER PERSON FOR EACH VIOLATION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2023.
