1 Each elected member serves for a term of 4 years beginning on (f) (1) $\mathbf{2}$ December 1 after the member's election and until a successor is elected and qualifies. The 3 terms of elected members are staggered as required by the terms of the members serving 4 on the county board as of July 1, 1978 so that 4 members are elected in gubernatorial election years and 3 members are elected in presidential election years. $\mathbf{5}$ 6 (2)Elected members of the county board shall be elected by the voters of 7 the entire county. 8 Of the 3 members elected in 1992 and every 4 years thereafter, 1 (3)(i) 9 shall reside in Board of Education District 2 and 1 shall reside in Board of Education 10 District 4. The third member may reside in any part of the county. 11 Of the 4 members elected in 1990 and every 4 years thereafter, 1 (ii) 12shall reside in Board of Education District 1, 1 shall reside in Board of Education District 3, and 1 shall reside in Board of Education District 5. The fourth member may reside in 13 14any part of the county. 15The descriptions of board of education districts in this subsection (iii) 16 refer to the geographical boundaries of the election districts and the precincts: 171. As reviewed and certified by the Montgomery County Board of Elections or its designees, before the precinct boundaries were reported to the U.S. 1819 Bureau of the Census as part of the 2020 Census Redistricting Data Program; and 202. As those precinct lines are specifically shown on the P.L. 2194–171 census block maps provided by the U.S. Bureau of the Census and as reviewed and 22corrected by the Division of Capital Planning and Real Estate of the Montgomery County 23Public Schools. 24(iv) Board of Education District 1 consists of: 251.
