5 annual amount of the products manufactured under a Class 9 limited distillery
6 license that the holder of the license may sell at retail on a certain premises for

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages**

2 (a) There is a Class 9 limited distillery license.

3 (d) A holder of the limited distillery license may not:

4 (1) apply for or possess a wholesaler’s license;

5 (2) sell bottles of the products manufactured at the Class 9 limited
6 distillery on that part of the premises used for the distillery operation;

7 (3) except as provided in subsection (e) of this section, distill, rectify, bottle,
8 or sell more than ~~100,000~~ ~~200,000~~ gallons of brandy, rum, whiskey, alcohol, and neutral
9 spirits each calendar year;

10 (4) sell at retail on the premises of the Class D or Class B license, for
11 on-sale or off-sale consumption, more than ~~15,500~~ ~~35,000~~ 31,000 gallons of the products
12 manufactured under the license each calendar year; and

13 (5) own, operate, or be affiliated in any manner with another
14 manufacturer.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
16 1, 2018.
