- FOR the purpose of prohibiting a person from purchasing, selling, offering for sale, or possessing with the intent to sell certain parts or products of certain animal species under certain circumstances, subject to certain exceptions; authorizing a court to order that a person who violates this Act pay certain restitution; requiring that fines and restitution imposed under this Act be credited to the State Wildlife Management and Protection Fund to be used for the preservation of threatened or endangered species; and generally relating to the prevention of wildlife trafficking in the State.

- 7 (d) The Department shall administer the Fund.
- 8 (e) (1) The Fund is a special, nonlapsing fund that is not subject to § 7–302 of 9 the State Finance and Procurement Article.
- 10 (2) The Treasurer shall hold the Fund separately and the Comptroller shall 11 account for the Fund.
- 12 (f) The Fund consists of:
- 13 (1) Any money received for a license, stamp, application, or permit fee 14 under this title, unless otherwise provided; [and]

- 19 (1) The scientific investigation, protection, propagation, and management 20 of wildlife; and
- 21 (2) Administrative costs calculated in accordance with $\S 1-103(b)(2)$ of this 22 article.
- 23 (h) (1) The Treasurer shall invest the money of the Fund in the same manner 24 as other State money may be invested.
- 25 (2) Any investment earnings of the Fund may not be transferred or revert 26 to the General Fund of the State, but shall remain in the Fund.
