## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2010 – Harford County – Nuttal**  
3 **Avenue Park**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2010  
5 to extend the deadline for a certain grantee to present evidence that a matching  
6 fund will be provided; and requiring that the Board of Public Works expend or  
7 encumber the proceeds of the loan by June 1, 2013; and generally relating to  
8 amending the Maryland Consolidated Capital Bond Loan of 2010.

9 BY repealing and reenacting, with amendments,  
10 Chapter 483 of the Acts of the General Assembly of 2010  
11 Section 1(3) Item ZA03(AI)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Chapter 483 of the Acts of 2010**

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That:

17 (3) ZA03 LOCAL HOUSE OF DELEGATES INITIATIVES

18 (AI) Nuttal Avenue Park. Provide a grant equal to the lesser of (i)  
19 \$100,000 or (ii) the amount of the matching fund provided, to  
20 the County Executive and County Council of Harford County  
21 for the construction of Nuttal Avenue Park, located in  
22 Edgewood. **NOTWITHSTANDING SECTION 1(5) OF THIS**  
23 **ACT, THE GRANTEE HAS UNTIL JUNE 1, 2013, TO**  
24 **PRESENT EVIDENCE THAT A MATCHING FUND WILL BE**

 4           **THE PURPOSES PROVIDED IN THIS ACT NO LATER THAN**  
 5           **JUNE 1, 2013** (Harford County) ..... 100,000

6           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
