1 AN ACT concerning

2 **Baltimore–Washington International Thurgood Marshall Airport – Security**  
3 **Screening Checkpoint – Charitable Donations**

4 FOR the purpose of requiring the Executive Director of the Maryland Aviation  
5 Administration to ~~place~~ work with a certain charitable entity to install secure  
6 donation boxes at the entrance to each security screening checkpoint at the  
7 Baltimore–Washington International Thurgood Marshall Airport; requiring that  
8 money deposited in the donation boxes be appropriated to the Department of  
9 Disabilities to be used only to support its education programs used only to support a  
10 certain charitable entity; defining a certain term; and generally relating to donation  
11 boxes and the Baltimore–Washington International Thurgood Marshall Airport.

14 Section 5–413.1

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

2 (A) IN THIS SECTION, "DONATION BOX" MEANS A CLEARLY MARKED  
3 RECEPTACLE FOR THE CHARITABLE DONATION OF MONEY BY THE PUBLIC.

4 (B) THE EXECUTIVE DIRECTOR SHALL ~~PLACE AND MAINTAIN~~ WORK WITH  
5 HOUSE OF RUTH MARYLAND TO INSTALL SECURE DONATION BOXES AT THE  
6 ENTRANCE TO EACH SECURITY SCREENING CHECKPOINT AT THE  
7 BALTIMORE-WASHINGTON INTERNATIONAL THURGOOD MARSHALL AIRPORT.

8 (C) THE MONEY DEPOSITED IN THE DONATION BOXES REQUIRED UNDER  
9 SUBSECTION (B) OF THIS SECTION SHALL BE ~~APPROPRIATED TO THE DEPARTMENT~~  
10 ~~OF DISABILITIES TO BE USED ONLY TO SUPPORT ITS EDUCATION PROGRAMS~~ USED  
11 ONLY TO SUPPORT HOUSE OF RUTH MARYLAND.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
13 October 1, 2020.
