A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore County – Remediation of Illegal Dumping – Report**

3 FOR the purpose of requiring the Baltimore County Department of Public Works to report
4 annually to the members of the Baltimore County Delegation to the General
5 Assembly on actions taken to remediate illegal dumping in each legislative district
6 in Baltimore County in which more than a certain number of citations for illegal
7 dumping were issued during the previous year; requiring the report to be made
8 available on the Department's website; and generally relating to the remediation of
9 illegal dumping in Baltimore County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Local Government**

18 **13–707.**

19 **(A) THIS SECTION APPLIES ONLY IN BALTIMORE COUNTY.**

20 **(B) ON OR BEFORE JANUARY 1 EACH YEAR, THE BALTIMORE COUNTY**
21 **DEPARTMENT OF PUBLIC WORKS SHALL:**

22 **(1) SUBMIT A REPORT TO THE MEMBERS OF THE BALTIMORE COUNTY**
23 **DELEGATION TO THE GENERAL ASSEMBLY, IN ACCORDANCE WITH § 2–1257 OF THE**

1 **STATE GOVERNMENT ARTICLE, ON THE ACTIONS THE DEPARTMENT HAS TAKEN TO**
2 **REMEDIATE ILLEGAL DUMPING IN EACH LEGISLATIVE DISTRICT IN BALTIMORE**
3 **COUNTY IN WHICH MORE THAN TEN CITATIONS FOR ILLEGAL DUMPING WERE**
4 **ISSUED DURING THE PREVIOUS YEAR; AND**

5 **(2) MAKE THE REPORT REQUIRED UNDER ITEM (1) OF THIS**
6 **SUBSECTION AVAILABLE TO THE PUBLIC ON THE DEPARTMENT'S WEBSITE.**

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 October 1, 2020.
