BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Alcoholic Beverages and Cannabis

- 23 (F) THE LICENSE HOLDER MAY PURCHASE BEER AND WINE FROM A RETAIL
- 24 <del>LICENSE HOLDER OR</del> A LICENSED WHOLESALER.
- 25 (G) THE ANNUAL LICENSE FEE IS \$300.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
- 27 1, 2024.
