3 FOR the purpose of requiring the Interagency Commission on School Construction to adopt regulations to set minimal standards for air quality standards; requiring each county 4 board of education to retain utilize the services of a qualified indoor air quality 5 6 investigator to conduct any indoor air quality tests the board chooses to have 7 conducted in a public school in the county; requiring a county board and the State 8 Department of Education, on receipt of a request by a member of the public for the 9 results of an indoor air quality test, to post the results on its website provide the results in a certain manner; requiring county boards of education to report to the 10 11 Interagency Commission certain information on air quality standards on or before a certain date; requiring the Interagency Commission to compile and report certain 12 information to the Governor and the General Assembly on or before a certain date; 13 and generally relating to indoor air quality testing in public schools. 14
