A BILL ENTITLED

1 AN ACT concerning

2 **School Health and Wellness Personnel Assessment and Maryland Council on**
3 **Advancement of School–Based Health Centers**

4 FOR the purpose of requiring the State Department of Education and the Maryland
5 Department of Health jointly to conduct an assessment of school health and wellness
6 personnel each year; altering the membership of the Maryland Council on
7 Advancement of School–Based Health Centers; and generally relating to school
8 health and wellness personnel and the Maryland Council on Advancement of
9 School–Based Health Centers.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
27 That the Laws of Maryland read as follows:

1 **Article – Health – General**

3 (a) There is a Maryland Council on Advancement of School–Based Health Centers
4 in the Department.

5 19–22A–06.

6 (a) The Council consists of the following **[15] 16** voting members and 6 ex officio
7 members:8 (1) One member of the Senate of Maryland, appointed by the President of
9 the Senate, as an ex officio member;10 (2) One member of the House of Delegates, appointed by the Speaker of the
11 House, as an ex officio member;12 (3) The Secretary of Health, or a designee of the Secretary, as an ex officio
13 member;

14 (4) The State Superintendent of Schools as an ex officio member;

15 (5) The Executive Director of the Maryland Health Benefit Exchange as an
16 ex officio member;17 (6) The Chairman of the Commission, or a designee of the Chairman, as an
18 ex officio member; and19 (7) The following **[15] 16** members, appointed by the Governor:20 (i) The President of the Maryland Assembly on School–Based
21 Health Care, or a designee of the President;22 (ii) Three representatives of school–based health centers, nominated
23 by the Maryland Assembly on School–Based Health Care:

24 1. From a diverse array of sponsoring organizations; and

25 2. For at least one of the representatives, from a nursing
26 background;27 (iii) One representative of the Public Schools Superintendents
28 Association of Maryland;

- 1 (iv) One representative of the Maryland Association of Boards of
2 Education;
- 3 (v) One elementary school principal of a school that has a
4 school-based health center;
- 5 (vi) One secondary school principal of a school that has a
6 school-based health center;
- 7 (vii) One representative of the Maryland Hospital Association;
- 8 (viii) One representative of the Maryland Association of County
9 Health Officers;
- 10 (ix) One representative of a federally qualified health center,
11 nominated by the Mid-Atlantic Association of Community Health Centers;
- 12 (x) One representative of a managed care organization;
- 13 (xi) One representative of a commercial health insurance carrier;
- 14 (xii) One pediatrician, nominated by the Maryland Chapter of the
15 American Academy of Pediatrics; [and]
- 16 (xiii) One parent or guardian of a student who utilizes services at a
17 school-based health center; AND
- 18 (XIV) ONE SCHOOL NURSE, NOMINATED BY THE MARYLAND
19 ASSOCIATION OF SCHOOL HEALTH NURSES.

20 **SUBTITLE 25. SCHOOL HEALTH AND WELLNESS PERSONNEL ASSESSMENT.**

22 **IN THIS SUBTITLE, "SCHOOL HEALTH AND WELLNESS PERSONNEL" INCLUDES:**

- 23 **(1) COUNSELORS;**
- 24 **(2) DENTAL HYGIENISTS;**
- 25 **(3) OCCUPATIONAL THERAPISTS;**
- 26 **(4) OCCUPATIONAL THERAPY ASSISTANTS;**
- 27 **(5) PHYSICAL THERAPISTS;**

- 1 **(6) SCHOOL COUNSELORS;**
2 **(7) SCHOOL NURSES;**
3 **(8) SCHOOL PSYCHOLOGISTS;**
4 **(9) SCHOOL SOCIAL WORKERS; AND**
5 **(10) SPEECH-LANGUAGE PATHOLOGISTS.**

7 **(A) THE DEPARTMENT AND THE STATE DEPARTMENT OF EDUCATION**
8 **JOINTLY SHALL CONDUCT AN ASSESSMENT OF THE SCHOOL HEALTH AND WELLNESS**
9 **PERSONNEL WORKFORCE IN THE STATE EACH YEAR TO:**

10 **(1) IDENTIFY THE RATIO OF SCHOOL HEALTH AND WELLNESS**
11 **PERSONNEL TO STUDENTS AND SCHOOLS BY JURISDICTION;**

12 **(2) OBTAIN INFORMATION FROM EACH LOCAL SCHOOL SYSTEM AND**
13 **LOCAL HEALTH DEPARTMENT REGARDING VACANCY RATES FOR EACH TYPE OF**
14 **PROVIDER OF SCHOOL HEALTH AND WELLNESS SERVICES; AND**

15 **(3) OBTAIN FEEDBACK FROM EACH LOCAL SCHOOL SYSTEM, EACH**
16 **LOCAL HEALTH DEPARTMENT, AND OTHER STAKEHOLDERS ON STRATEGIES TO**
17 **IMPROVE THE RECRUITMENT AND RETENTION OF SCHOOL HEALTH AND WELLNESS**
18 **PERSONNEL.**

19 **(B) ON OR BEFORE DECEMBER 1, 2027, AND EACH DECEMBER 1**
20 **THEREAFTER, THE DEPARTMENT AND THE STATE DEPARTMENT OF EDUCATION**
21 **JOINTLY SHALL SUBMIT A REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE**
22 **WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, ON THE FINDINGS OF THE**
23 **ASSESSMENT CONDUCTED UNDER THIS SECTION.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
25 October 1, 2025.
