A BILL ENTITLED

1 AN ACT concerning

2 **Small, Minority, and Women–Owned Businesses Account – Funding**

3 FOR the purpose of repealing certain required appropriations from the proceeds of video
4 lottery terminals at certain video lottery facilities; and generally relating to funding
5 and the Small, Minority, and Women–Owned Businesses Account.

6 BY repealing and reenacting, with amendments,

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

12 That the Laws of Maryland read as follows:

13 **Article – State Government**

14 9–1A–27.

15 (a) Except as provided in subsections (b) and (c) of this section and §
16 9–1A–26(a)(3) of this subtitle, on a properly approved transmittal prepared by the
17 Commission, the Comptroller shall pay the following amounts from the proceeds of video
18 lottery terminals at each video lottery facility:

19 (6) [(i) except as provided in items (ii) and (iii) of this item,] 1.5% to the
20 Small, Minority, and Women–Owned Businesses Account established under § 5–1501 of
21 the Economic Development Article;

22 [(ii) for fiscal year 2018, 1.5% to the General Fund to pay a portion of

1 the costs of the grants provided under Chapters 6 and 607 of the Acts of the General
2 Assembly of 2017;

3 (iii) for fiscal years 2019 and 2020, 1.5% to the Education Trust Fund
4 established under § 9–1A–30 of this subtitle; and

5 (iv) beginning in fiscal year 2021, from the amount paid to the Small,
6 Minority, and Women–Owned Businesses Account under item (i) of this item, up to 5%, not
7 to exceed \$1,000,000, to the Nonprofit, Interest–Free, Micro Bridge Loan (NIMBL) Account
8 established under § 5–1204 of the Economic Development Article;]

9 (c) (1) For the first 10 years of operations at a video lottery facility in Allegany
10 County, on a properly approved transmittal prepared by the Commission, the Comptroller
11 shall pay the following amounts from the proceeds of video lottery terminals at a video
12 lottery facility in Allegany County:

13 (v) [1. except as provided in items 2 and 3 of this item,] 0.75% to
14 the Small, Minority, and Women–Owned Businesses Account established under § 5–1501
15 of the Economic Development Article;

16 [2. for fiscal year 2018, 0.75% to the General Fund to pay a
17 portion of the costs of the grants provided under Chapters 6 and 607 of the Acts of the
18 General Assembly of 2017; and

19 3. for fiscal years 2019 and 2020, 0.75% to the Education
20 Trust Fund established under § 9–1A–30 of this subtitle;] and

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
22 1, 2019.
