## CHAPTER \_\_\_\_\_

1 AN ACT concerning

### 2 **Orphans' Court – Minors – Guardianship of Person**

3 FOR the purpose of providing that an orphans' court may exercise jurisdiction over  
4 guardianship of the person of a minor regardless of whether the presiding judge  
5 of the orphans' court is a member of the Bar of Maryland; providing for the  
6 application of this Act; and generally relating to the jurisdiction of an orphans'  
7 court over guardianship of the person of a minor.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

### 15 **Article – Estates and Trusts**

16 13–105.

17 (a) (1) The orphans' courts and the circuit courts have concurrent  
18 jurisdiction over guardians of the person of a minor and over protective proceedings for  
19 minors.

1 (2) Upon petition of an interested person, a matter initiated in the  
2 orphans' court may be transferred to the circuit court.

3 (b) The circuit courts have exclusive jurisdiction over protective proceedings  
4 for disabled persons.

5 (c) (1) An orphans' court may exercise jurisdiction over guardianship of  
6 the person of a minor [if the presiding judge of the orphans' court is a member of the  
7 bar], regardless of whether the minor who is the subject of the petition for  
8 guardianship of the person has property, may inherit property, or is destitute.

9 (2) An orphans' court that exercises jurisdiction or is requested to  
10 exercise jurisdiction under this subsection may:

11 (i) Transfer the matter to the circuit court on a finding that the  
12 best interests of the child require utilization of the equitable powers of the circuit  
13 court; and

14 (ii) Waive the costs, if any, of a transfer under this paragraph.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be  
16 construed to apply only prospectively and may not be applied or interpreted to have  
17 any effect on or application to any petition for guardianship of the person of a minor  
18 filed before the effective date of this Act.

19 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
20 October 1, 2010.
