3 FOR the purpose of requiring the State Department of Education, in consultation with the Maryland Department of Health and the Department of General Services, to adopt 4 $\mathbf{5}$ regulations on or before a certain date establishing uniform standards for mold 6 assessment and remediation in public schools, including requiring each county board 7 of education to establish a process for reporting and assessing potential mold in a public school and remediating mold identified during a mold assessment; requiring a county board and the State Department of Education, on receipt of the results of a mold assessment, to post the results online in a certain manner; and generally 10relating to mold assessment and remediation in public schools.
