1 AN ACT concerning

2 **Freedom to Read Act**

3 FOR the purpose of establishing a State policy that local school systems operate their school
4 library media programs consistent with certain standards; requiring each local
5 school system to develop a policy and procedures to review objections to materials in
6 a school library media program; prohibiting a county board of education from taking
7 certain actions against certain school library media program personnel for
8 performing their job duties consistent with certain standards; establishing the State
9 standards for libraries for the operation of each library that receives funding from
10 the State; altering the duties of the State Library Board, the State Library Agency,
11 and regional resource centers to incorporate the State standards for libraries;
12 making funding for certain libraries contingent on adoption of a written policy for
13 operation of the library consistent with the State standards for libraries; requiring

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

(A) IT IS THE POLICY OF THE STATE THAT EACH LOCAL SCHOOL SYSTEM OPERATE ITS SCHOOL LIBRARY MEDIA PROGRAM CONSISTENT WITH THE FOLLOWING STANDARDS:

(1) THE MATERIALS, SERVICES, AND RESOURCES PROVIDED IN A SCHOOL LIBRARY MEDIA PROGRAM ARE PROVIDED FOR THE INTEREST, INFORMATION, AND INSTRUCTIONAL SUPPORT OF STUDENTS AND SCHOOL PERSONNEL OF THE SCHOOLS THE PROGRAM SERVES;

(2) MATERIALS MAY NOT BE EXCLUDED FROM A SCHOOL LIBRARY MEDIA PROGRAM SOLELY BECAUSE OF THE ORIGIN, BACKGROUND, OR VIEWS OF THE INDIVIDUAL WHO CREATED THE MATERIAL; AND

26 (a) In addition to the other powers granted and duties imposed by this article, the
 27 State Library Board has the powers and duties set forth in this section.

28 (b) The State Library Board shall appoint the State Librarian.

29 (c) The State Library Board shall exercise general direction and control of library
 30 development in this State and may:

31 (1) Adopt rules and regulations necessary to administer this title;

1 (2) After considering the recommendations of the State Librarian,
2 establish library policies and procedures for the statewide system of libraries;

3 (3) Consider the library needs of this State and recommend to the Governor
4 and the General Assembly desirable legislation; and

5 (4) With the approval of the Governor, accept, administer, and spend any
6 appropriation, gift, or grant for library purposes from the federal government or from any
7 other person.

8 (d) In accordance with the bylaws, rules, and regulations of the State Board of
9 Education, the State Superintendent shall certificate professional library personnel.

10 (e) (1) Each year the State Library Board shall report to the Governor and the
11 people of this State on the support, condition, progress, and needs of libraries.

13 any findings of the State Library Agency related to its duties under § 23-106(b)(4) of this
14 subtitle.

15 (f) The State Library Board shall approve county public library capital projects
16 for State funding in accordance with § 23-509 of this title.

17 **(G) THE STATE LIBRARY BOARD SHALL DEVELOP POLICIES FOR THE**

21 (a) In addition to any other powers granted and duties imposed by this title, and
22 subject to the authority of the State Library Board, the State Library Agency has the
23 powers and duties set forth in this section.

24 (b) The State Library Agency shall:

25 (1) Provide leadership and guidance for the planning and coordinated
26 development of library and information service in this State;

27 (2) Develop statewide public and school library services and networks,
28 resource centers, and other arrangements to meet the library and information needs of this
29 State;

30 (3) Provide professional and technical advice on improving library services

- 9 (5) Administer federal and State funds appropriated to it by the State for

- 11 (6) (i) Develop and recommend professional standards and policies for
12 libraries; and
- 13 (ii) Establish requirements and procedures for the certification of
14 librarians and library personnel;
- 15 (7) Provide:
- 16 (i) Specialized library service to the blind and other print disabled
17 individuals in this State; and
- 18 (ii) Other desirable specialized library services;
- 19 (8) Encourage, advise, and assist in establishing, operating, and
20 coordinating libraries at State institutions and agencies and administer the operation of
21 library and information services for the State Library Board;
- 22 (9) Administer the State grant program for county public library capital
23 projects, in accordance with § 23–509 of this title;
- 24 (10) Adopt guidelines for the administration of public libraries and
25 recommend to the State Library Board rules and regulations to implement this title;
- 26 (11) Cooperate with national library agencies and those of any other state;
- 27 (12) Develop a Deaf Culture Digital Library in accordance with § 23–109 of

4 (14) Perform any other duty necessary for its proper operation.

6 (a) The boards of library trustees of at least three public library systems outside
7 the standard metropolitan statistical areas defined by the United States Bureau of the
8 Census may request the State Library Board to establish and maintain a regional resource
9 center.

10 (b) Each regional resource center shall provide, through mutual cooperation and
11 coordination, books, information, and other material and service resources that an
12 individual library cannot provide adequately by itself.

13 (c) (1) A region to be served by a regional resource center shall have a
14 population of at least 100,000.

15 (2) Subject to approval by the State Library Board, the boards of library
16 trustees of the participating library systems shall designate the library to serve as the
17 resource center.

18 (d) (1) There is a board of advisors for each regional resource center that shall
19 act as the Regional Advisory Council.

20 (2) The Council consists of:

21 (i) The director of the regional resource center; and

22 (ii) The director of each member library system.

23 (3) The Council for each regional resource center shall:

24 (i) Gather information on the resource needs of its region; and

25 (ii) Promote the use of the regional resource center.

26 (e) (1) The director of the regional resource center is the executive officer of
27 the regional resource center.

28 (2) The director:

29 (i) Is appointed by the governing board established in accordance
30 with § 23-202.1 of this subtitle; and

1 (ii) Shall serve at the pleasure of the governing board.

2 (3) The director shall:

3 (i) Be eligible for certification as a professional library director by
4 the State Superintendent of Schools as set forth in COMAR 14.38.01.01;

5 (ii) Have the powers and duties set forth in this title; and

6 (iii) Appoint, promote, fix salaries, assign duties, and terminate
7 personnel of the regional resource center.

8 (f) (1) The director shall operate the regional resource center in accordance
9 with:

10 (i) The standards adopted by the State Library Board; and

11 (ii) The policies adopted by the governing board.

12 (2) The director shall:

13 (i) Prepare and submit for the approval of the governing board the
14 annual budget of the regional resource center;

15 (ii) Adopt and submit for the approval of the governing board
16 reasonable rules and bylaws to carry out this section; and

17 (iii) Recommend to the governing board the purchase, condemnation,
18 rental, use, sale, or conveyance of property for any valid purpose under this section.

19 (g) (1) The policies and procedures of the regional resource center shall be:

20 [(1)] (I) Recommended by the board of trustees of the library designated
21 as the regional resource center; and

22 [(2)] (II) Approved by the Council.

23 (2) **THE POLICIES AND PROCEDURES FOR OPERATION OF THE**

26 (h) Each regional resource center shall:

27 (1) Make interlibrary loans of books and materials;

- 1 (2) Supply collections and exhibits of specialized materials;
- 2 (3) Provide consultant services;
- 3 (4) Organize in-service training for library staffs; and
- 4 (5) Develop and operate cooperative services among libraries.

5 23-202.1.

6 (a) There is a governing board for each regional resource center.

7 (b) (1) Except as provided in paragraph (2) of this subsection, a governing
8 board consists of the following members:

9 (i) A library trustee from each participating library system; and

10 (ii) Up to one member of the public from each area served by the
11 participating library systems.

12 (2) (i) The board of trustees of the Washington County Free Library
13 shall act as the governing board for the Western Maryland Regional Resource Center.

14 (ii) The bylaws adopted by the board of trustees of the Washington
15 County Free Library shall govern the composition, appointment, qualifications, terms, and
16 structure of the governing board.

17 (c) A member appointed to a governing board must:

18 (1) Be of good character;

19 (2) Have demonstrated ability and interest in library matters; and

20 (3) Be a resident of one of the counties participating in and being served by
21 the regional resource center.

22 (d) (1) Subject to paragraph (2) of this subsection, the members of the
23 governing board shall be appointed by the governing board.

24 (2) The initial members of a governing board shall be appointed by the
25 Regional Advisory Council of the regional resource center.

26 (e) A member of a governing board:

27 (1) May not receive compensation as a member of the governing board; but

1 (2) Is entitled to reimbursement for expenses in accordance with the rules,
2 policies, and bylaws of the regional resource center.

3 (f) (1) Each member serves for a term of 5 years beginning July 1 immediately
4 following the member's appointment and until a successor is appointed and qualifies.

5 (2) A member may not serve for more than two consecutive terms.

6 (3) (i) The governing board shall appoint a qualified individual to fill
7 any vacancy in the member's position for the remainder of that term until a successor is
8 appointed and qualifies.

9 (ii) A member appointed to fill a vacancy under subparagraph (i) of
10 this paragraph may serve for two additional terms.

11 (g) (1) A governing board shall elect a chair from among its members each
12 year.

13 (2) A governing board may elect any other officers determined necessary
14 by the board.

15 (3) If a governing board elects a treasurer, the treasurer shall be
16 appropriately bonded.

17 (h) (1) A governing board:

18 (i) Shall determine the time and place of its meetings; and

19 (ii) May adopt rules for the conduct of its meetings.

20 (2) A governing board shall meet at least once every 3 months.

21 (3) A governing board is subject to the Open Meetings Act.

22 (4) A majority of the appointed members of the governing board is a
23 quorum.

24 (i) (1) A member of a governing board who fails to attend at least 50% of the
25 scheduled meetings of the board during any consecutive 12-month period shall be
26 considered to have resigned.

27 (2) If the member has been unable to attend meetings for reasons
28 satisfactory to the governing board, the governing board may waive the resignation.

29 (3) The chair of a governing board shall report the member's name and
30 nonattendance to the State Library Board within 45 days after the end of the 12-month
31 period.

1 (4) The governing board shall fill any vacancy in accordance with
2 subsection (f) of this section.

3 (j) (1) In addition to the other powers expressly granted and duties imposed
4 by this subtitle, a governing board has the powers and duties set forth in this subsection.

5 (2) A governing board shall:

6 (i) Select and appoint, with the advice of the State Librarian, a
7 professional librarian to serve as director of the regional resource center;

8 (ii) Determine the policies of the regional resource center;

9 (iii) Adopt reasonable rules and bylaws for the use of the regional
10 resource center and the conduct of its business;

11 (iv) Approve the regional resource center budget;

12 (v) In accordance with the regulations and laws of the State, receive,
13 account for, control, and supervise the spending of all public funds received by the regional
14 resource center;

15 **(VI) ADOPT AND FOLLOW A WRITTEN POLICY FOR OPERATION**
16 **OF THE REGIONAL RESOURCE CENTER THAT IS CONSISTENT WITH THE STATE**
17 **STANDARDS FOR LIBRARIES AND CONDUCT THE OPERATION OF THE REGIONAL**
18 **RESOURCE CENTER IN A MANNER CONSISTENT WITH THE WRITTEN POLICY;**

19 **[(vi)] (VII)** Publish the results of the audit conducted under
20 paragraph (4)(ii) of this subsection; and

21 **[(vii)] (VIII)** Submit a report to the State Librarian on or before
22 November 1 each year that includes:

23 1. The amount of money received from the library fund and
24 other sources;

25 2. Itemized expenses;

26 3. The number of books and periodicals in the possession of
27 and owned by the regional resource center;

28 4. The results of the annual audit; and

29 5. Any other information required by the State Library
30 Board.

1 (3) A governing board may:

2 (i) Apply, accept, and expend any gift, appropriation, or grant from
3 the State, county, or federal government or any other person on behalf of the regional
4 resource center;

5 (ii) Recommend the purchase, condemnation, rental, acquisition,
6 use, or conveyance of property for any valid purpose under this section;

7 (iii) Recommend plans for the regional resource centers, including
8 the use of facilities of participating libraries, additions to the facilities of participating
9 libraries, or new facilities separate from the existing facilities of participating libraries;

10 (iv) Select the location of and approve plans for the erection of
11 regional resource center buildings, subject to the approval of the State Library Board and
12 the Governor;

13 (v) Make agreements with any person for any library service; and

14 (vi) Perform any other actions necessary for the proper control and
15 development of the regional resource center.

16 (4) In addition to other reports that may be required by the State Library
17 Board, the Board shall:

18 (i) Keep records that are consistent with sound business practices
19 and accounting records that use generally accepted accounting principles;

20 (ii) Cause an audit by an independent certified public accountant
21 approved by the State Librarian to be made of the accounts and transactions of the regional
22 resource center at the conclusion of each fiscal year; and

23 (iii) For any State money, be subject to an audit by the Office of
24 Legislative Audits, in accordance with §§ 2-1220 through 2-1227 of the State Government
25 Article.

26 **(K) THE GOVERNING BOARD MAY NOT DISMISS, SUSPEND, DISCIPLINE,**
27 **DEMOTE, REASSIGN, TRANSFER, OR OTHERWISE RETALIATE AGAINST AN EMPLOYEE**
28 **FOR ACTING IN A MANNER CONSISTENT WITH THE REGIONAL RESOURCE CENTER'S**
