4 FOR the purpose of altering the composition of the Cox Creek Citizens Oversight
5 Committee; altering the duties of the Oversight Committee; and generally relating
6 to the Cox Creek Citizens Oversight Committee.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Environment**

20 5–1101.

1 (a) In this subtitle the following words have the meanings indicated.

2 (5) "Dredged material" means earth, sand, silt, sediment, shell, rock, soil,
3 waste matter, or other material excavated or dredged from the Chesapeake Bay and its
4 tributary waters.

6 (a) (1) The Governor shall appoint a Cox Creek Citizens Oversight Committee.

7 (2) The terms of the members of the Oversight Committee shall be
8 determined by the Governor.

9 (b) The Oversight Committee shall be composed of the following members:

10 (1) 2 members of the North County Land Trust;

11 (2) 1 delegate to the Greater Pasadena Council who represents a
12 waterfront community;

13 (3) 1 member of the Pasadena Sport Fishermen's Group;

14 (4) 1 member of the Anne Arundel County Watermen's Association;

15 (5) 1 member of the Maryland Saltwater Sport Fishermen's Association;

16 (6) 1 individual who represents the pleasure boating industry in Anne
17 Arundel County;

18 (7) 1 member of the Pasadena Business Association;

19 **(8) 1 MEMBER OF THE RESTORE ROCK CREEK ORGANIZATION;**

20 **(9) 1 MEMBER OF THE SOUTH BALTIMORE BUSINESS ALLIANCE;**

21 **[(8)] (10) 1 resident of legislative district 31; and**

22 **[(9)] (11) 1 resident of legislative district 46.**

23 (c) The Oversight Committee shall:

24 (1) Monitor the redeposit of Anne Arundel County [tributary spoil]
25 **DREDGED MATERIAL** and other [spoil] **DREDGED MATERIAL** in the Cox Creek area;

1 (2) Hear and dispose of complaints lodged by individuals affected by the
2 redeposit of Anne Arundel County [tributary spoil] **DREDGED MATERIAL** and other [spoil]
3 **DREDGED MATERIAL** in the Cox Creek area; and

4 (3) Appoint a member from the Committee to serve as a liaison to the
5 Innovative Use Advisory Council.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 October 1, 2015.
