1 AN ACT concerning

2 **State Procurement – Small Business Preference Procurement**

3 FOR the purpose of requiring each procurement unit to establish a price preference for
4 small businesses; designating the Board of Public Works as the regulatory authority
5 for the Small Business Preference Program; ~~specifying the manner in which a unit~~
6 ~~may achieve targets for procurement awards to small businesses;~~ and generally
7 relating to small business procurement.

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
9 That the Laws of Maryland read as follows:

10 **Article – State Finance and Procurement**

11 14–202.

12 (a) This subtitle applies to procurement of supplies, services, and construction
13 related services by[:

14 (1) the Department of General Services;

15 (2) the Department of Transportation;

16 (3) the University System of Maryland;

17 (4) Morgan State University; and

18 (5) as provided in subsection (b) of this section, the Department of Public
19 Safety and Correctional Services in connection with construction of a State correctional
20 facility under § 12–107 of this article] **ANY UNIT OR AGENCY OF THE EXECUTIVE**
21 **BRANCH OF STATE GOVERNMENT.**

22 (b) For procurements in connection with the construction of a State correctional
23 facility, the Department of Public Safety and Correctional Services shall:

24 (1) apply the percentage price preferences established by the Department
25 of General Services under this subtitle; and

26 (2) follow the same procedures established by the Department of General
27 Services to comply with this subtitle.

29 (a) By regulation, the [Secretary of General Services, the Secretary of
30 Transportation, the Chancellor of the University System of Maryland, and the President of

1 Morgan State University each] **BOARD** shall specify the criteria that a business must meet
2 to qualify as a small business.

3 (b) (1) The criteria for qualification as a small business may vary among
4 industries to reflect their particular characteristics.

5 (2) Regulations adopted under this section shall include, for each class of
6 business, the maximum number of employees a business may have to qualify as a small
7 business.

8 (c) The regulations adopted under subsection (a) of this section shall require the
9 qualification of a business as a small business for the exclusive purpose of pursuing
10 out-of-state contracts, if the business has:

11 (1) 250 or fewer employees; or

12 (2) average annual gross receipts of \$10,000,000 or less averaged over its
13 most recently completed 3 fiscal years.

15 The [Secretary of General Services, the Secretary of Transportation, and the
16 Chancellor of the University System of Maryland each] **BOARD** shall adopt regulations to
17 establish procedures for:

18 (1) compiling and maintaining a comprehensive bidder's list of small
19 businesses;

20 (2) locating potential sources for various construction related services,
21 supplies, and services and affirmatively seeking to locate potential minority business
22 enterprise sources for those construction related services, supplies, and services;

23 (3) helping small businesses to comply with the procedures for bidding on
24 procurement contracts;

25 (4) examining requests for construction related services, supplies, and
26 services to determine when an invitation for bids may be designated for the Small Business
27 Preference Program;

28 (5) bidding for a procurement contract designated for a small business
29 preference;

30 (6) simplifying procurement specifications and terms, to increase the
31 opportunities for small business participation;

1 (7) investigating the responsibility of bidders on small business
2 preferences; and

3 (8) explaining to a small business the reason for which its bid for a small
4 business preference was rejected.

6 The Department of Commerce shall help the [Secretaries of General Services and
7 Transportation and the Chancellor of the University System of Maryland] **BOARD** in
8 establishing procedures to carry out § 14–204(1) and (2) of this subtitle.

9 14–206.

10 (a) In this section, “percentage preference” means the percent of the lowest
11 responsive bid submitted by a responsible bidder who is not a small business by which a
12 responsive bid by a small business may:

13 (1) exceed the lowest bid; and

14 (2) be awarded a procurement contract under this subtitle.

15 (b) Subject to the approval of the Board, [the Secretary of General Services, the
16 Secretary of Transportation, and the Chancellor of the University System of Maryland]
17 each **UNIT**:

18 (1) shall establish a percentage preference, not to exceed 8%, for each
19 industry as follows:

20 (i) a base percentage preference not to exceed 5% for all small
21 businesses; and

22 (ii) two additional preferences to the percentage preference set forth
23 in item (i) of this paragraph as follows:

24 1. 2% for veteran–owned small businesses; and

25 2. 3% for disabled veteran–owned small businesses; and

26 (2) may vary the percentage preference determined in item (1)(i) of this
27 subsection among industries to account for their particular characteristics.

29 (a) The [Secretary of General Services, the Secretary of Transportation, and the
30 Chancellor of the University System of Maryland each] ~~**BOARD**~~ **UNIT** may designate, for

1 the Small Business Preference Program, procurement of certain supplies, services, or
 2 construction related services that have been requested through or with the approval of the
 3 **[Secretary or Chancellor] HEAD OF THE UNIT**.

4 (b) The invitation for bids on a procurement that has been designated for a small
 5 business preference shall be sent to small businesses and regular bidders to establish a
 6 reasonable price range commensurate with current market conditions.

7 (c) **[The Secretary of General Services, the Secretary of Transportation, or the**
 8 **Chancellor of the University System of Maryland] A UNIT** shall award a procurement
 9 contract designated for a small business preference to the small business that:

10 (1) is a responsible bidder; and

11 (2) submits the lowest responsive bid from a small business if the
 12 difference between that bid and the lowest responsive bid submitted by a responsible bidder
 13 who is not a small business does not exceed the percentage preference established under §
 14 14-206 of this subtitle.
