1 AN ACT concerning

2 **Climate Change Adaptation and Mitigation Payment Program and Climate**
3 **Impact Health Coverage Program – Establishment**

4 FOR the purpose of establishing the Climate Change Adaptation and Mitigation Payment
5 Program in the Department of the Environment to secure payments from certain
6 businesses that extract fossil fuels or refine petroleum products in order to provide
7 a source of revenue for certain climate change adaptive or mitigation infrastructure
8 projects and efforts to address the health impacts of climate change on vulnerable
9 populations; establishing the Climate Change Adaptation and Mitigation Fund as a
10 special, nonlapsing fund; authorizing the Legislative Auditor to conduct certain
11 audits of the Fund and of the appropriations and expenditures made for the purposes
12 of the Climate Change Adaptation and Mitigation Payment Program; altering the
13 purpose of the Maryland Health Benefit Exchange to include the provision of funding
14 for the establishment and operation of the Climate Impact Health Coverage
15 Program; requiring the Maryland Health Benefit Exchange to establish and
16 implement the Climate Impact Health Coverage Program to facilitate the enrollment
17 of certain individuals in qualified plans and, based on the availability of funds,
18 provide State premium assistance and cost–sharing reductions to certain individuals
19 enrolled in qualified plans; providing that the implementation of the Climate Impact
20 Health Coverage Program is contingent on approval of a certain waiver application;
21 and generally relating to the Climate Change Adaptation and Mitigation Payment
22 Program and the Climate Impact Health Coverage Program.

11 Preamble

12 WHEREAS, Climate change, resulting primarily from the combustion of fossil fuels,
13 is an immediate, grave threat to the State’s communities, environment, and economy; and

14 WHEREAS, In addition to mitigating the further buildup of greenhouse gases, the
15 State must take action to adapt to certain consequences of climate change that are
16 irreversible, including rising sea levels, increasing temperatures, extreme weather events,
17 flooding, heat waves, toxic algae blooms, and other threats; and

18 WHEREAS, Meeting the challenge of adapting to and mitigating the effects of
19 climate change will require a shared commitment of purpose and huge investments in new
20 or upgraded infrastructure; and

21 WHEREAS, The State has previously adopted programs, such as the Cigarette
22 Restitution Fund Program, to require industries that have profited by harming the public
23 welfare to shoulder their share of the burden in redressing that harm; and

24 WHEREAS, Based on decades of research, it is now possible to determine with great
25 accuracy the share of greenhouse gases released into the atmosphere by specific fossil fuel
26 companies over the last 70 years or more, making it possible to assign liability and require
27 compensation from companies commensurate with their emissions during a given time
28 period; now, therefore,

29 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
30 That the Laws of Maryland read as follows:

13 **(IV) PREPARE FOR AND RECOVER FROM HURRICANES AND**
14 **OTHER EXTREME WEATHER EVENTS;**

15 **(V) RELOCATE, ELEVATE, OR RETROFIT WASTEWATER**
16 **TREATMENT PLANTS THAT ARE VULNERABLE TO FLOODING;**

17 **(VI) INSTALL HEAT PUMPS AND OTHER CLEAN ENERGY**
18 **RETROFITS IN PUBLIC AND PRIVATE BUILDINGS, INCLUDING SCHOOL BUILDINGS;**
19 **AND**

20 **(VII) RESPOND TO TOXIC ALGAE BLOOMS, THE LOSS OF**
21 **AGRICULTURAL TOPSOIL, AND OTHER CLIMATE-DRIVEN ECOSYSTEM THREATS TO**

4 **REGARD TO § 1563(B)(2)(C) OF THE INTERNAL REVENUE CODE; OR**

6 **(F) “COST RECOVERY DEMAND” MEANS A CHARGE ASSERTED AGAINST A**
7 **RESPONSIBLE PARTY FOR COST RECOVERY PAYMENTS UNDER THE PROGRAM.**

8 **(G) “COVERED GREENHOUSE GAS EMISSIONS” MEANS THE TOTAL**
9 **QUANTITY OF GREENHOUSE GASES RELEASED INTO THE ATMOSPHERE DURING THE**
10 **COVERED PERIOD, EXPRESSED IN METRIC TONS OF CARBON DIOXIDE EQUIVALENT,**
11 **RESULTING FROM THE USE OF FOSSIL FUELS OR PETROLEUM PRODUCTS**
12 **EXTRACTED, PRODUCED, REFINED, OR SOLD BY AN ENTITY.**

13 **(H) “COVERED PERIOD” MEANS JANUARY 1, 2000, THROUGH DECEMBER**
14 **31, 2018, INCLUSIVE.**

15 **(I) (1) “CRUDE OIL” MEANS OIL OR PETROLEUM OF ANY KIND AND IN**
16 **ANY FORM.**

17 **(2) “CRUDE OIL” INCLUDES:**

18 **(I) BITUMEN;**

19 **(II) OIL SANDS;**

20 **(III) HEAVY OIL;**

21 **(IV) CONVENTIONAL AND UNCONVENTIONAL OIL;**

22 **(V) SHALE OIL;**

23 **(VI) NATURAL GAS LIQUIDS;**

24 **(VII) CONDENSATES; AND**

25 **(VIII) RELATED FOSSIL FUELS.**

26 **(J) “ENTITY” MEANS ANY INDIVIDUAL, TRUSTEE, AGENT, PARTNERSHIP,**
27 **ASSOCIATION, CORPORATION, COMPANY, MUNICIPAL CORPORATION, POLITICAL**

1 SUBDIVISION, OR OTHER PERSON, INCLUDING A FOREIGN NATION, THAT HOLDS OR
2 HELD AN OWNERSHIP INTEREST IN A FOSSIL FUEL BUSINESS DURING THE COVERED
3 PERIOD.

4 (K) "FOSSIL FUEL" MEANS COAL, PETROLEUM PRODUCTS, AND FUEL
5 GASES.

6 (L) "FOSSIL FUEL BUSINESS" MEANS A BUSINESS ENGAGING IN THE
7 EXTRACTION OF FOSSIL FUELS OR THE REFINING OF PETROLEUM PRODUCTS.

8 (M) "FUEL GAS" INCLUDES:

9 (1) METHANE;

10 (2) NATURAL GAS;

11 (3) LIQUIFIED NATURAL GAS; AND

12 (4) MANUFACTURED FUEL GASES.

13 (N) "FUND" MEANS THE CLIMATE CHANGE ADAPTATION AND MITIGATION
14 FUND ESTABLISHED UNDER § 2-1704 OF THIS SUBTITLE.

15 (O) "GREENHOUSE GAS" HAS THE MEANING STATED IN § 2-1202 OF THIS
16 TITLE.

17 (P) "NOTICE OF COST RECOVERY DEMAND" MEANS A WRITTEN
18 COMMUNICATION INFORMING A RESPONSIBLE PARTY OF THE AMOUNT OF THE COST
19 RECOVERY DEMAND PAYABLE TO THE DEPARTMENT UNDER THIS SUBTITLE.

20 (Q) "PETROLEUM PRODUCT" MEANS ANY PRODUCT REFINED OR
21 RE-REFINED FROM:

22 (1) SYNTHETIC OR CRUDE OIL; OR

23 (2) CRUDE OIL EXTRACTED FROM NATURAL GAS LIQUIDS OR OTHER
24 SOURCES.

25 (R) "PROGRAM" MEANS THE CLIMATE CHANGE ADAPTATION AND
26 MITIGATION PAYMENT PROGRAM ESTABLISHED UNDER § 2-1702 OF THIS
27 SUBTITLE.

1 **(S) (1) “QUALIFYING EXPENDITURE” MEANS AN AUTHORIZED PAYMENT**
2 **FROM THE FUND IN SUPPORT OF A CLIMATE CHANGE ADAPTIVE OR MITIGATION**
3 **INFRASTRUCTURE PROJECT.**

4 **(2) “QUALIFYING EXPENDITURE” INCLUDES, TO THE EXTENT**
5 **AUTHORIZED IN DEPARTMENT REGULATIONS, A PAYMENT TOWARD THE OPERATION**
6 **AND MAINTENANCE OF A CLIMATE CHANGE ADAPTIVE OR MITIGATION**
7 **INFRASTRUCTURE PROJECT.**

8 **(T) (1) “RESPONSIBLE PARTY” MEANS AN ENTITY, OR A SUCCESSOR IN**
9 **INTEREST TO AN ENTITY, THAT:**

10 **(I) DURING ANY PART OF THE COVERED PERIOD, WAS**
11 **ENGAGED IN THE TRADE OR BUSINESS OF EXTRACTING FOSSIL FUEL OR REFINING**
12 **CRUDE OIL; AND**

13 **(II) IS DETERMINED BY THE DEPARTMENT TO BE RESPONSIBLE**
14 **FOR MORE THAN 1,000,000,000 TONS OF COVERED GREENHOUSE GAS EMISSIONS.**

15 **(2) “RESPONSIBLE PARTY” DOES NOT INCLUDE ANY PERSON THAT**
16 **LACKS SUFFICIENT CONNECTION WITH THE STATE TO SATISFY THE NEXUS**
17 **REQUIREMENTS OF THE UNITED STATES CONSTITUTION.**

19 **(A) THERE IS A CLIMATE CHANGE ADAPTATION AND MITIGATION**
20 **PAYMENT PROGRAM IN THE DEPARTMENT.**

21 **(B) THE PURPOSE OF THE PROGRAM IS TO:**

22 **(1) SECURE COMPENSATORY PAYMENTS FROM FOSSIL FUEL**
23 **BUSINESSES BASED ON A STANDARD OF STRICT LIABILITY IN ORDER TO PROVIDE A**
24 **SOURCE OF REVENUE FOR:**

25 **(I) CLIMATE CHANGE ADAPTIVE OR MITIGATION**
26 **INFRASTRUCTURE PROJECTS WITHIN THE STATE; AND**

27 **(II) STATE EFFORTS TO ADDRESS THE HEALTH IMPACTS OF**
28 **CLIMATE CHANGE ON VULNERABLE POPULATIONS;**

29 **(2) DETERMINE THE PROPORTIONAL LIABILITY OF RESPONSIBLE**
30 **PARTIES IN ACCORDANCE WITH § 2-1703 OF THIS SUBTITLE;**

1 **(3) IMPOSE COST RECOVERY DEMANDS ON RESPONSIBLE PARTIES**
2 **AND ISSUE NOTICES OF COST RECOVERY DEMANDS;**

3 **(4) ACCEPT AND COLLECT COST RECOVERY PAYMENTS FROM**
4 **RESPONSIBLE PARTIES;**

5 **(5) IDENTIFY CLIMATE CHANGE ADAPTIVE OR MITIGATION**
6 **INFRASTRUCTURE PROJECTS WITHIN THE STATE;**

7 **(6) DISBURSE FUNDS IN ACCORDANCE WITH THIS SUBTITLE; AND**

8 **(7) ENSURE THAT AT LEAST 40% OF THE QUALIFIED EXPENDITURES**
9 **FROM THE PROGRAM GO TO CLIMATE CHANGE ADAPTIVE OR MITIGATION**
10 **INFRASTRUCTURE PROJECTS THAT DIRECTLY BENEFIT COMMUNITIES**
11 **DISPROPORTIONATELY AFFECTED BY CLIMATE IMPACTS.**

12 **2-1703.**

13 **(A) (1) A RESPONSIBLE PARTY IS STRICTLY LIABLE, WITHOUT REGARD**
14 **TO FAULT, FOR A SHARE OF THE COSTS OF CLIMATE CHANGE ADAPTIVE OR**
15 **MITIGATION PROJECTS, INCLUDING OPERATING AND MAINTENANCE COSTS,**
16 **SUPPORTED BY THE FUND.**

17 **(2) FOR PURPOSES OF THIS SECTION, ENTITIES IN A CONTROLLED**
18 **GROUP:**

19 **(I) SHALL BE TREATED BY THE DEPARTMENT AS A SINGLE**
20 **ENTITY FOR THE PURPOSES OF IDENTIFYING RESPONSIBLE PARTIES; AND**

21 **(II) ARE JOINTLY AND SEVERALLY LIABLE FOR PAYMENT OF**
22 **ANY COST RECOVERY DEMAND OWED BY ANY ENTITY IN THE CONTROLLED GROUP.**

23 **(B) WITH RESPECT TO EACH RESPONSIBLE PARTY, THE COST RECOVERY**
24 **DEMAND SHALL BE EQUAL TO AN AMOUNT THAT BEARS THE SAME RATIO TO**
25 **\$9,000,000,000 AS THE RESPONSIBLE PARTY'S APPLICABLE SHARE OF COVERED**
26 **GREENHOUSE GAS EMISSIONS BEARS TO THE AGGREGATE APPLICABLE SHARES OF**
27 **ALL RESPONSIBLE PARTIES' COVERED GREENHOUSE GAS EMISSIONS.**

28 **(C) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A**
29 **RESPONSIBLE PARTY'S APPLICABLE SHARE OF GREENHOUSE GAS EMISSIONS SHALL**
30 **BE THE AMOUNT BY WHICH THE COVERED GREENHOUSE GAS EMISSIONS**
31 **ATTRIBUTABLE TO THE RESPONSIBLE PARTY EXCEEDS 1,000,000,000 METRIC TONS.**

1 **(2) IF A RESPONSIBLE PARTY OWNS A MINORITY INTEREST OF 10% OR**
2 **MORE IN ANOTHER ENTITY, THE RESPONSIBLE PARTY'S APPLICABLE SHARE OF**
3 **GREENHOUSE GAS EMISSIONS SHALL BE CALCULATED AS THE APPLICABLE SHARE**
4 **OF GREENHOUSE GAS EMISSIONS FOR THE ENTITY IN WHICH THE RESPONSIBLE**
5 **PARTY HOLDS A MINORITY INTEREST, AS CALCULATED UNDER PARAGRAPH (1) OF**
6 **THIS SUBSECTION, MULTIPLIED BY THE PERCENTAGE OF THE MINORITY INTEREST**
7 **HELD BY THE RESPONSIBLE PARTY.**

8 **(3) IN DETERMINING THE AMOUNT OF GREENHOUSE GAS EMISSIONS**
9 **ATTRIBUTABLE TO AN ENTITY, THE DEPARTMENT SHALL ASSUME THAT:**

10 **(I) 942.5 METRIC TONS OF CARBON DIOXIDE EQUIVALENT IS**
11 **RELEASED FOR EVERY 1,000,000 POUNDS OF COAL ATTRIBUTABLE TO THE ENTITY;**

12 **(II) 432,180 METRIC TONS OF CARBON DIOXIDE EQUIVALENT IS**
13 **RELEASED FOR EVERY 1,000,000 BARRELS OF CRUDE OIL ATTRIBUTABLE TO THE**
14 **ENTITY; AND**

15 **(III) 53,440 METRIC TONS OF CARBON DIOXIDE EQUIVALENT IS**
16 **RELEASED FOR EVERY 1,000,000 CUBIC FEET OF FUEL GASES ATTRIBUTABLE TO**
17 **THE ENTITY.**

18 **(D) THE DEPARTMENT MAY ADJUST THE COST RECOVERY DEMAND**
19 **AMOUNT OF A RESPONSIBLE PARTY THAT REFINES PETROLEUM PRODUCTS OR THAT**
20 **IS A SUCCESSOR IN INTEREST TO AN ENTITY THAT REFINES PETROLEUM PRODUCTS,**
21 **IF THE RESPONSIBLE PARTY ESTABLISHES TO THE SATISFACTION OF THE**
22 **DEPARTMENT THAT:**

23 **(1) A PORTION OF THE COST RECOVERY DEMAND AMOUNT WAS**
24 **ATTRIBUTABLE TO THE REFINING OF CRUDE OIL EXTRACTED BY ANOTHER ENTITY;**
25 **AND**

26 **(2) THE CRUDE OIL EXTRACTED BY THE OTHER ENTITY WAS**
27 **ACCOUNTED FOR WHEN THE DEPARTMENT DETERMINED THE COST RECOVERY**
28 **DEMAND AMOUNT FOR THE OTHER ENTITY OR A SUCCESSOR IN INTEREST OF THE**
29 **OTHER ENTITY.**

30 **(E) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A**
31 **RESPONSIBLE PARTY SHALL PAY THE COST RECOVERY DEMAND AMOUNT IN FULL**
32 **ON OR BEFORE OCTOBER 1, 2025.**

1 **(2) (I) A RESPONSIBLE PARTY MAY ELECT TO PAY THE COST**
2 **RECOVERY DEMAND AMOUNT IN NINE ANNUAL INSTALLMENTS IN ACCORDANCE**
3 **WITH THIS PARAGRAPH.**

4 **(II) THE FIRST INSTALLMENT SHALL BE PAID ON OR BEFORE**
5 **OCTOBER 1, 2025, AND SHALL BE EQUAL TO 20% OF THE TOTAL COST RECOVERY**
6 **DEMAND AMOUNT.**

7 **(III) EACH SUBSEQUENT INSTALLMENT SHALL BE PAID ON OR**
8 **BEFORE SEPTEMBER 30 EACH SUBSEQUENT YEAR AND SHALL BE EQUAL TO 10% OF**
9 **THE TOTAL COST RECOVERY DEMAND AMOUNT.**

10 **(IV) 1. THE UNPAID BALANCE OF ALL REMAINING**
11 **INSTALLMENTS SHALL BECOME DUE IMMEDIATELY IF:**

12 **A. THE RESPONSIBLE PARTY FAILS TO PAY ANY**
13 **INSTALLMENT IN A TIMELY MANNER, AS SPECIFIED IN DEPARTMENT REGULATIONS;**

14 **B. EXCEPT AS PROVIDED IN SUBSUBPARAGRAPH 2 OF**
15 **THIS SUBPARAGRAPH, THERE IS A LIQUIDATION OR SALE OF SUBSTANTIALLY ALL**
16 **THE ASSETS OF THE RESPONSIBLE PARTY, INCLUDING IN A BANKRUPTCY**
17 **PROCEEDING; OR**

18 **C. THE RESPONSIBLE PARTY CEASES TO DO BUSINESS.**

19 **2. IN THE CASE OF A SALE OF SUBSTANTIALLY ALL THE**
20 **ASSETS OF A RESPONSIBLE PARTY, THE REMAINING INSTALLMENTS SHALL NOT**
21 **BECOME DUE IMMEDIATELY IF THE BUYER ENTERS INTO AN AGREEMENT WITH THE**
22 **DEPARTMENT UNDER WHICH THE BUYER ASSUMES LIABILITY FOR THE REMAINING**
23 **INSTALLMENTS DUE UNDER THIS SUBPARAGRAPH IN THE SAME MANNER AS IF THE**
24 **BUYER WERE THE RESPONSIBLE PARTY.**

25 **(F) THE DEPARTMENT SHALL DEPOSIT COST RECOVERY PAYMENTS**
26 **COLLECTED UNDER THIS SECTION TO THE CLIMATE CHANGE ADAPTATION AND**
27 **MITIGATION FUND ESTABLISHED UNDER § 2-1704 OF THIS SUBTITLE.**

28 **(G) A RESPONSIBLE PARTY MAY REQUEST A HEARING UNDER TITLE 10,**
29 **SUBTITLE 2 OF THE STATE GOVERNMENT ARTICLE (ADMINISTRATIVE PROCEDURE**
30 **ACT – CONTESTED CASES) TO CONTEST A COST RECOVERY DEMAND MADE BY THE**
31 **DEPARTMENT UNDER THIS SECTION.**

32 **2-1704.**

1 (A) THERE IS A CLIMATE CHANGE ADAPTATION AND MITIGATION FUND.

2 (B) THE PURPOSE OF THE FUND IS TO PROVIDE FUNDING FOR CLIMATE
3 CHANGE ADAPTIVE OR MITIGATION INFRASTRUCTURE PROJECTS IN THE STATE.

4 (C) THE DEPARTMENT SHALL ADMINISTER THE FUND.

5 (D) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT
6 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

7 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,
8 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

9 (E) THE FUND CONSISTS OF:

10 (1) COST RECOVERY PAYMENTS DISTRIBUTED TO THE FUND UNDER
11 § 2-1703 OF THIS SUBTITLE;

12 (2) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;
13 AND

14 (3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR
15 THE BENEFIT OF THE FUND.

16 (F) THE FUND MAY BE USED ONLY:

17 (1) TO PAY:

18 (i) QUALIFIED EXPENDITURES FOR CLIMATE CHANGE
19 ADAPTIVE OR MITIGATION INFRASTRUCTURE PROJECTS IDENTIFIED BY THE
20 DEPARTMENT IN ACCORDANCE WITH REGULATIONS ADOPTED UNDER § 2-1705 OF
21 THIS SUBTITLE; AND

22 (ii) REASONABLE ADMINISTRATIVE COSTS OF THE PROGRAM;
23 AND
