A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2011 – Howard County – The**
3 **Arc of Howard County – Graeoch Home Renovation**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2011
5 to alter the purpose of a certain grant for The Arc of Howard County – Graeoch
6 Home Renovation; extending the deadline for a certain grantee to present
7 evidence of a certain matching fund; providing that a certain grant may not
8 terminate before a certain date; and generally relating to the Maryland
9 Consolidated Capital Bond Loan of 2011.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

20 **THE ARC'S HOMEWOOD ROAD RENOVATION.** Provide a
21 grant equal to the lesser of (i) \$145,000 or (ii) the amount of
22 the matching fund provided, to the Board of Directors of The
23 Arc of Howard County, Inc. for the **PLANNING, DESIGN,**
24 construction, **REPAIR,** renovation, **RECONSTRUCTION,** and

3 Notwithstanding Section 1(5) of this Act, the matching fund
4 may consist of in kind contributions. **NOTWITHSTANDING**
5 **SECTION 1(5) OF THIS ACT, THE GRANTEE HAS UNTIL**
6 **JUNE 1, 2015, TO PRESENT EVIDENCE THAT A MATCHING**
7 **FUND WILL BE PROVIDED. NOTWITHSTANDING SECTION**
8 **1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE**
9 **BEFORE JUNE 1, 2015** (Howard County) 145,000

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 June 1, 2014.
