CHAPTER _____

1 AN ACT concerning

2 **Cecil County – Orphans’ Court – Sessions**

3 FOR the purpose of altering the frequency of the sessions of the Orphans’ Court in Cecil
4 County; and generally relating to the sessions of the Orphans’ Court in Cecil County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Estates and Trusts**

18 2–106.

1 (a) Except as provided in this section and unless a different time is prescribed by
2 local law, the court shall be held in each county at the usual place of holding court in the
3 county, on the second Tuesday of February, April, June, August, October, and December,
4 and more often if need be, according to its own adjournment. One of the judges of the court,
5 in the absence of the others, shall have power to hold court at a stated time of adjournment
6 only for the purpose of adjourning. Two judges shall have full power to do an act which the
7 court is or may be authorized by law to perform, and two of them shall have power to hold
8 court on a day not named in an adjournment, on the application of a person having pressing
9 business in the court, if notice be given to any interested person, and the register records
10 that notice has been given. One of the judges, in the absence of the others on account of
11 prolonged illness, or in case of vacancy, shall have full power to do an act which the court
12 is authorized by law to do, provided there is attached to the proceedings or papers in each
13 case a certificate signed by the register, certifying to the vacancy or prolonged illness of the
14 judge or judges not attending court on that day. If the court does not meet on a day fixed
15 for its meeting and is not adjourned as provided, the register shall adjourn the court from
16 day to day until a meeting is had according to law.

17 **(J) IN CECIL COUNTY, THE SESSIONS OF THE COURT SHALL BE HELD**
18 **EVERY TUESDAY FOR THE TRANSACTION OF THE BUSINESS OF THE COURT, AND**
19 **MORE OFTEN IF NEED BE, ACCORDING TO ITS OWN ADJOURNMENT.**

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2015.
