## A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Class B–HTF (Hatchet Throwing**  
3 **Facility) License**

4 FOR the purpose of establishing a Class B–HTF (hatchet throwing facility) beer and wine  
5 license in Frederick County; authorizing the Board of License Commissioners for  
6 Frederick County to issue the license; and generally relating to alcoholic beverages  
7 licenses in Frederick County.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
25 That Section(s) 20–1009.1 and 20–1009.2 of Article – Alcoholic Beverages of the Annotated  
26 Code of Maryland be renumbered to be Section(s) 20–1009.2 and 20–1009.3, respectively.

1 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
2 as follows:

3 **Article – Alcoholic Beverages**

4 20–102.

5 This title applies only in Frederick County.

6 **20–1009.1.**

7 **(A) THERE IS A CLASS B–HTF (HATCHET THROWING FACILITY) BEER AND**  
8 **WINE LICENSE.**

9 **(B) THE BOARD MAY ISSUE THE LICENSE FOR USE BY A HATCHET**  
10 **THROWING FACILITY THAT:**

11 **(1) IS OPEN TO THE PUBLIC;**

12 **(2) HAS AT LEAST FIVE HATCHET THROWING PITS; AND**

13 **(3) IN THE DISCRETION OF THE BOARD BASED ON AN APPROVED**  
14 **FLOOR PLAN, HAS AMPLE SPACE AND ACCOMMODATIONS PREDOMINANTLY**  
15 **DEDICATED TO HATCHET THROWING PITS AND SEATING FOR VIEWING THE HATCHET**  
16 **THROWING PITS.**

17 **(C) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL AT RETAIL**  
18 **BEER AND WINE FOR ON–PREMISES CONSUMPTION ONLY.**

19 **(D) THE LICENSE HOLDER SHALL OFFER FOOD ON–PREMISES AT ALL TIMES**  
20 **WHEN ALCOHOLIC BEVERAGES ARE BEING SERVED.**

21 **(E) THE LICENSE HOLDER SHALL ENSURE THAT THE ANNUAL GROSS**  
22 **REVENUE FROM:**

23 **(1) THE SALE OF ALCOHOLIC BEVERAGES DOES NOT EXCEED 35% OF**  
24 **THE LICENSE HOLDER’S TOTAL ANNUAL GROSS REVENUE;**

25 **(2) HATCHET THROWING RENTAL FEES IS AT LEAST 50% OF THE**  
26 **LICENSE HOLDER’S TOTAL ANNUAL GROSS REVENUE; AND**

27 **(3) THE SALE OF FOOD IS AT LEAST 15% OF THE LICENSE HOLDER’S**  
28 **TOTAL ANNUAL GROSS REVENUE.**

1           **(F) AS A PREREQUISITE FOR THE RENEWAL OF THE LICENSE, THE LICENSE**  
2 **HOLDER SHALL REPORT TO THE BOARD THE PERCENTAGE OF ANNUAL GROSS**  
3 **REVENUE DERIVED FROM THE SALE OF ALCOHOLIC BEVERAGES, HATCHET**  
4 **THROWING RENTAL FEES, AND THE SALE OF FOOD FOR THE PREVIOUS CALENDAR**  
5 **YEAR TO VERIFY THAT THE FACILITY HAS MET THE REQUIREMENTS OF SUBSECTION**  
6 **(E) OF THIS SECTION.**

7           **(G) THE LICENSE HOLDER MAY SELL BEER AND WINE DURING THE HOURS**  
8 **AND DAYS AS SET OUT FOR A CLASS B BEER AND WINE LICENSE UNDER § 20-2004**  
9 **OF THIS TITLE.**

10           **(H) THE BOARD MAY ADOPT REGULATIONS TO CARRY OUT THIS SECTION.**

11           **(I) THE ANNUAL LICENSE FEE IS \$1,500.**

12           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
13 1, 2023.
