## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2010 – Baltimore City – Glen**  
3 **Avenue Firehouse**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2010  
5 to alter the deadline for the Mayor and City Council of the City of Baltimore to  
6 present evidence of a certain matching fund and to encumber funds for a certain  
7 grant; and generally relating to amending the Maryland Consolidated Capital  
8 Bond Loan of 2010.

9 BY repealing and reenacting, with amendments,  
10 Chapter 483 of the Acts of the General Assembly of 2010, as amended by  
11 Chapter 396 of the Acts of the General Assembly of 2011  
12 Section 1(3) Item ZA03(M)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Chapter 483 of the Acts of 2010, as amended by Chapter 396 of the Acts of**  
16 **2011**

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
18 MARYLAND, That:

19 (3) ZA03 LOCAL HOUSE OF DELEGATES INITIATIVES

20 (M) Glen Avenue Firehouse. Provide a grant equal to the lesser of  
21 (i) \$75,000 or (ii) the amount of the matching fund provided,  
22 to the Mayor and City Council of the City of Baltimore for the  
23 repair, renovation, and capital equipping of the Glen Avenue  
24 Firehouse, located in Baltimore City. Notwithstanding Section  
25 1(5) of this Act, the matching fund may consist of real

1 property, in kind contributions, or funds expended prior to the  
 2 effective date of this Act **AND THE GRANTEE HAS UNTIL**  
 3 **JUNE 1, 2014, TO PRESENT EVIDENCE THAT A MATCHING**  
 4 **FUND WILL BE PROVIDED. NOTWITHSTANDING SECTION**  
 5 **1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE**  
 6 **BEFORE JUNE 1, 2014** (Baltimore City) ..... 75,000

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 8 June 1, 2013.
