HOUSE JOINT RESOLUTION

1 A House Joint Resolution concerning

2 **Legislative Districting Plan of 2012**

3 FOR the purpose of establishing a plan for legislative districts pursuant to Article III,
4 Section 5 of the Maryland Constitution; providing that this Joint Resolution
5 shall be effective as a plan within the meaning of Article III, Section 5 of the
6 Maryland Constitution only under certain circumstances; and generally relating
7 to the establishment of legislative districts pursuant to Article III of the
8 Maryland Constitution.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
26 MARYLAND, That Section(s) 2–202 of Article – State Government of the Annotated
27 Code of Maryland be repealed.



1 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
2 read as follows:

3 **Article – State Government**

4 Subtitle 2. Legislative Districting Plan of [2002] **2012**.

5 2–201.

6 (a) The State of Maryland is divided into 47 districts for the election of
7 members of the General Assembly of Maryland.

8 (b) Each legislative district shall elect 1 Senator and 3 Delegates.

9 (c) Each legislative district may be subdivided into 3 single member delegate
10 districts or into 1 single member delegate district and 1 multimember delegate
11 district.

12 (d) In any legislative district which contains more than 2 counties:

13 (1) where Delegates are to be elected at large by the voters of the
14 entire district, a county, or part of a county, may not have more than 1 Delegate
15 residing in that district; and

16 (2) where Delegates are to be elected by the voters of a multimember
17 subdistrict which contains more than 2 counties or parts of more than 2 counties, a
18 county or a part of a county may not have more than 1 Delegate residing in that
19 subdistrict.

20 (e) (1) The descriptions of legislative districts in this [order] **SUBTITLE**,
21 including all references to:

22 (i) election districts and wards are to the geographical
23 boundaries of the election districts and wards as they existed as of April 1, [2000]
24 **2010**; and

25 (ii) precincts are to the geographical boundaries of the precincts
26 as reviewed and certified by the local board of supervisors of elections or their
27 designees, before they were reported to the U.S. Bureau of the Census as part of the
28 [2000] **2010** Census Redistricting Data Program and as those precinct lines are
29 specifically indicated in the P.L. 94–171 data or shown on the P.L. 94–171 census
30 block maps provided by the U.S. Bureau of the Census and as reviewed and corrected
31 by the Maryland Department of Planning.

32 (2) Where precincts are split between legislative districts, census tract
33 and block numbers, as indicated in the P.L. 94–171 data or shown on the P.L. 94–171

1 census block maps provided by the U.S. Bureau of the Census and referred to in §
2 2–202 of this subtitle, are used to define the boundaries of legislative districts.

3 (f) For purposes of elections, the provisions of this [order] SUBTITLE shall
4 be applicable to elections for members of the General Assembly beginning with the
5 primary and general elections of [2002] 2014 and, for purposes of representation,
6 shall be applicable beginning with the second Wednesday of January [2003] 2015.
