## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **University of Baltimore – Schaefer Center for Public Policy – Funding and**  
3 **Staffing Requirement**

4 FOR the purpose of requiring the Governor to include a certain appropriation in the annual  
5 budget bill for the Schaefer Center for Public Policy at the University of Baltimore;  
6 requiring the Schaefer Center for Public Policy to provide staff for the Apprenticeship  
7 2030 Commission and altering the report date of the Commission; and generally  
8 relating to funding and staffing requirements for the Schaefer Center for Public  
9 Policy.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
2 That the Laws of Maryland read as follows:

3 **Article – Education**

4 **12–124.**

5 ~~BEGINNING IN FISCAL YEAR 2025~~ **FOR EACH OF FISCAL YEARS 2025 THROUGH**  
6 **2027, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN**  
7 **APPROPRIATION OF ~~\$1,900,000~~ \$1,500,000 TO THE SCHAEFER CENTER FOR**  
8 **PUBLIC POLICY AT THE UNIVERSITY OF BALTIMORE.**

9 **Chapter 168 of the Acts of 2023**

10 SECTION 2. AND BE IT FURTHER ENACTED, That:

11 (a) (1) There is an Apprenticeship 2030 Commission.

12 (d) The **SCHAEFER CENTER FOR PUBLIC POLICY AT THE UNIVERSITY OF**  
13 **BALTIMORE, IN CONSULTATION WITH THE** Department of Legislative Services, **AND**  
14 with the assistance of staff from the State agencies represented on the Commission, shall  
15 provide staff for the Commission.

16 (g) On or before December 1, [2023] 2024, the Commission shall report its  
17 findings and recommendations to the Governor and, in accordance with § 2–1257 of the  
18 State Government Article, the General Assembly.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
20 1, 2024.
