# Secretary of State - Address Confidentiality Programs - Merger of Programs and Expanded Participant Eligibility

4 FOR the purpose of merging the Address Confidentiality Program and the Human Trafficking Address Confidentiality Program into a single Address Confidentiality  $\mathbf{5}$ 6 Program administered by the Secretary of State; expanding certain eligibility 7 requirements for the Address Confidentiality Program to include certain individuals; 8 repealing the requirement that a request by a Program participant to withdraw from 9 the Address Confidentiality Program be notarized; repealing a requirement that the 10 Secretary of State cancel the participation of a Program participant under certain circumstances; authorizing the Secretary of State to cancel the participation of a 11 12 Program participant under certain circumstances; defining certain terms; altering certain definitions; making certain technical changes; and generally relating to 13 address confidentiality programs administered by the Secretary of State. 14
