A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Organizations – Criminal Prohibitions, Civil Actions, and Forfeiture**

3 FOR the purpose of establishing the statute of limitations for a certain civil action for
4 damages resulting from certain participation in a criminal organization; altering
5 certain definitions of “criminal organization” and “underlying crime”; authorizing the
6 filing of and establishing procedures for a civil action for injunctive relief and
7 damages arising out of certain participation in a criminal organization; establishing
8 procedures for the forfeiture of property connected to certain participation in a
9 criminal organization; and generally relating to criminal organizations.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
10 That the Laws of Maryland read as follows:

11 **Article – Courts and Judicial Proceedings**

12 **5–122.**

13 **A CIVIL ACTION FOR DAMAGES RESULTING FROM PARTICIPATION IN A**
14 **CRIMINAL ORGANIZATION BROUGHT UNDER § 9–808 OF THE CRIMINAL LAW**
15 **ARTICLE SHALL BE BROUGHT WITHIN 5 YEARS AFTER THE CONDUCT IN VIOLATION**
16 **OF § 9–804 OF THE CRIMINAL LAW ARTICLE TERMINATES.**

17 **Article – Criminal Law**

18 9–801.

19 (a) In this subtitle the following words have the meanings indicated.

20 (b) “Coerce” means to compel or attempt to compel another by threat of harm or
21 other adverse consequences.

22 (c) “Criminal organization” means an enterprise, **INCLUDING AN INFORMAL**
23 **ASSOCIATION**, whose members:

24 (1) individually or collectively engage in a pattern of organized crime
25 activity;

26 (2) have as one of their primary objectives or activities the commission of
27 one or more underlying crimes, including acts by juveniles that would be underlying crimes
28 if committed by adults; and

29 (3) have in common an overt or covert organizational or command
30 structure.

31 (d) “Enterprise” includes:

1 (1) a sole proprietorship, partnership, corporation, business trust, or other
2 legal entity; or

3 (2) any group of individuals associated in fact although not a legal entity.

4 (e) “Pattern of organized crime activity” means the commission of, attempted
5 commission of, conspiracy to commit, or solicitation of two or more underlying crimes or
6 acts by a juvenile that would be an underlying crime if committed by an adult, provided the
7 crimes or acts were not part of the same incident.

8 (f) “Solicit” has the meaning stated in § 11–301 of this article.

9 (g) “Underlying crime” means:

10 (1) a crime of violence as defined under § 14–101 of this article;

11 (2) a violation of § 3–203 (second degree assault), § 3–1102 (sex trafficking),
12 § 3–1103 (forced marriage), § 4–203 (wearing, carrying, or transporting a handgun), §
13 **4–204 (USE OF A FIREARM IN THE COMMISSION OF A CRIME)**, §
14 7–113 (embezzlement by fiduciary), or § 7–315 (theft – telecommunications–related) of this
15 article, § 9–102 (subornation of perjury), § 9–202(a) (bribery of juror), § 9–302 (inducing
16 false testimony or avoidance of subpoena), § 9–303 (retaliation for testimony), § 9–305
17 (intimidating or corrupting juror), § 9–306 (obstruction of justice), § 9–307 (destruction of
18 evidence), § **9–412 (CONTRABAND – IN GENERAL)**, § 9–413 (contraband – for escape), §
19 9–416 (contraband – controlled dangerous substance), or § 9–417 (contraband –
20 telecommunications–related) of this title, or § 11–304 (receiving earnings of prostitute), §
21 11–307 (house of prostitution), or § 12–104 (gaming offenses) of this article;

22 (3) a felony violation of § 3–701 (extortion), § 4–503 (manufacture or
23 possession of destructive device), § 5–602 (distribution of CDS), § 5–603 (manufacturing
24 CDS or equipment), § 5–604(b) (creating or possessing a counterfeit substance), § 5–606
25 (false prescription), § 6–103 (second degree arson), § 6–202 (first degree burglary), § 6–203
26 (second degree burglary), § 6–204 (third degree burglary), § 7–104 (theft), or § 7–105
27 (unauthorized use of a motor vehicle) of this article;

28 (4) a felony violation of § 5–133 of the Public Safety Article;

29 **(5) THE COMMON LAW MISDEMEANOR OF MISCONDUCT IN OFFICE;**

30 **(6) FRAUD AND RELATED CRIMES UNDER TITLE 8 OF THIS ARTICLE;**

31 **(7) BRIBERY UNDER SUBTITLE 2 OF THIS TITLE;**

32 **(8) FALSE STATEMENTS UNDER SUBTITLE 5 OF THIS TITLE;**

1 **(9) IMPERSONATING A POLICE OFFICER UNDER § 3-502 OF THE**
2 **PUBLIC SAFETY ARTICLE;**

3 **(10) THREAT OF MASS VIOLENCE UNDER TITLE 3, SUBTITLE 10 OF**
4 **THIS ARTICLE;**

5 **(11) INDECENCY AND OBSCENITY UNDER TITLE 11, SUBTITLE 1 OR**

9 **(13) A VIOLATION OF THE MARYLAND CONSUMER PROTECTION ACT**
10 **UNDER TITLE 13 OF THE COMMERCIAL LAW ARTICLE;**

11 **(14) REMOVAL OR FALSIFICATION OF VEHICLE IDENTIFICATION**
12 **NUMBER UNDER § 14-107 OF THE TRANSPORTATION ARTICLE;**

13 **(15) ABUSE OR NEGLECT OF A VULNERABLE ADULT UNDER § 3-604 OR**
14 **§ 3-605 OF THIS ARTICLE;**

15 **[(5)] (16)** a crime under the laws of another state or of the United States
16 that would be a crime listed in items (1) through **[(4)] (15)** of this subsection if committed
17 in this State; or

18 **[(6)] (17)** the attempted commission of, conspiracy to commit, or
19 solicitation of a crime or act listed in items (1) through **[(5)] (16)** of this subsection.

20 9-804.

21 (a) A person may not:

22 (1) participate in a criminal organization knowing that the members of the
23 criminal organization engage in a pattern of organized crime activity; and

24 (2) knowingly and willfully direct or participate in an underlying crime, or
25 act by a juvenile that would be an underlying crime if committed by an adult, committed
26 for the benefit of, at the direction of, or in association with a criminal organization.

27 (b) A criminal organization or an individual belonging to a criminal organization
28 may not:

29 (1) receive proceeds known to have been derived directly or indirectly from
30 an underlying crime; and

1 (2) use or invest, directly or indirectly, an aggregate of \$10,000 or more of
2 the proceeds from an underlying crime in:

3 (i) the acquisition of a title to, right to, interest in, or equity in real
4 property; or

5 (ii) the establishment or operation of any enterprise.

6 (c) A criminal organization may not acquire or maintain, directly or indirectly,
7 any interest in or control of any enterprise or real property through an underlying crime.

8 (d) A person may not conspire to violate subsection (a), (b), or (c) of this section.

9 (e) A person may not violate subsection (a) of this section that results in the death
10 of a victim.

11 (f) (1) (i) Except as provided in subparagraph (ii) of this paragraph, a
12 person who violates this section is guilty of a felony and on conviction is subject to
13 imprisonment not exceeding 15 years or a fine not exceeding \$1,000,000 or both.

14 (ii) A person who violates subsection (e) of this section is guilty of a
15 felony and on conviction is subject to imprisonment not exceeding 25 years or a fine not
16 exceeding \$5,000,000 or both.

17 (2) (i) A sentence imposed under paragraph (1)(i) of this subsection for
18 a first offense may be separate from and consecutive to or concurrent with a sentence for
19 any crime based on the act establishing a violation of this section.

20 (ii) A sentence imposed under paragraph (1)(i) of this subsection for
21 a second or subsequent offense, or paragraph (1)(ii) of this subsection shall be separate from
22 and consecutive to a sentence for any crime based on the act establishing a violation of this
23 section.

24 (iii) A consecutive sentence for a second or subsequent offense shall
25 not be mandatory unless the State notifies the person in writing of the State's intention to
26 proceed against the person as a second or subsequent offender at least 30 days before trial.

27 (3) In addition to the other penalties provided in this subsection, on
28 conviction the court may:

29 (i) order a person or criminal organization to be divested of any
30 interest in an enterprise or real property;

31 (ii) order the dissolution or reorganization of an enterprise; and

1 (iii) order the suspension or revocation of any license, permit, or prior
2 approval granted to the enterprise or person by a unit of the State or a political subdivision
3 of the State.

4 (g) (1) This subsection applies to a violation of § 5–602, § 5–603, § 5–604(b), §
5 5–606, § 5–612, § 5–613, § 5–614, or § 5–617 of this article.

6 (2) Assets divested under this section and derived from the commission of,
7 attempted commission of, conspiracy to commit, or solicitation of a crime described in
8 paragraph (1) of this subsection, either in whole or in part:

9 (i) if the State investigated and prosecuted a violation described in
10 paragraph (1) of this subsection, shall be deposited in the Addiction Treatment Divestiture
11 Fund established under § 8–6D–01 of the Health – General Article; or

12 (ii) if a local jurisdiction investigated and prosecuted a violation
13 described in paragraph (1) of this subsection, shall be used by the local jurisdiction:

14 1. to support alternatives to incarceration, reentry programs,
15 and addiction treatment services for persons with substance–related disorders;

16 2. to combat criminal organizations through education,
17 training, and resources; or

18 3. to provide assistance to victims of criminal
19 organization–related crimes; and

20 (iii) if more than one jurisdiction participated in an investigation or
21 a prosecution of a violation described in paragraph (1) of this subsection, shall be divided
22 in the manner agreed on by the jurisdictions and used as provided in item (i) or (ii) of this
23 paragraph.

24 (h) A person may be charged with a violation of this section only by indictment,
25 criminal information, or petition alleging a delinquent act.

26 (i) (1) The Attorney General, at the request of the Governor or the State’s
27 Attorney for a county in which a violation or an act establishing a violation of this section
28 occurs, may:

29 (i) aid in the investigation of the violation or act; and

30 (ii) prosecute the violation or act.

31 (2) In exercising authority under paragraph (1) of this subsection, the
32 Attorney General has all the powers and duties of a State’s Attorney, including the use of
33 the grand jury in the county, to prosecute the violation.

1 (3) Notwithstanding any other provision of law, in circumstances in which
2 violations of this section are alleged to have been committed in more than one county, the
3 respective State's Attorney of each county, or the Attorney General, may join the causes of
4 action in a single complaint with the consent of each State's Attorney having jurisdiction
5 over an offense sought to be joined.

6 (j) Notwithstanding any other provision of law and provided at least one criminal
7 organization activity of a criminal organization allegedly occurred in the county in which a
8 grand jury is sitting, the grand jury may issue subpoenas, summon witnesses, and
9 otherwise conduct an investigation of the alleged criminal organization's activities and
10 offenses in other counties.

12 (A) AN AGGRIEVED PERSON OR THE STATE MAY FILE A COMPLAINT IN
13 CIRCUIT COURT TO ENJOIN A VIOLATION OF § 9-804 OF THIS SUBTITLE.

14 (B) A COURT MAY, AFTER MAKING DUE PROVISIONS FOR THE RIGHTS OF
15 INNOCENT PERSONS, GRANT A COMPLAINT FILED UNDER SUBSECTION (A) OF THIS
16 SECTION BY ISSUING APPROPRIATE ORDERS AND JUDGMENTS, INCLUDING:

17 (1) ORDERING A DEFENDANT TO DIVEST ANY INTEREST IN AN
18 ENTERPRISE, REAL PROPERTY, OR PERSONAL PROPERTY;

19 (2) IMPOSING REASONABLE RESTRICTIONS ON THE FUTURE
20 ACTIVITIES OR INVESTMENTS OF A DEFENDANT, INCLUDING PROHIBITING THE
21 DEFENDANT FROM ENGAGING IN THE SAME TYPE OF ENDEAVOR AS THE
22 ENTERPRISE IN WHICH THE DEFENDANT WAS ENGAGED IN VIOLATION OF § 9-804 OF
23 THIS SUBTITLE;

24 (3) ORDERING THE DISSOLUTION OR REORGANIZATION OF AN
25 ENTERPRISE;

26 (4) ORDERING THE SUSPENSION OR REVOCATION OF A LICENSE,
27 PERMIT, OR PRIOR APPROVAL GRANTED TO AN ENTERPRISE BY A STATE AGENCY;
28 AND

29 (5) ORDERING THE FORFEITURE OF THE CHARTER OF A
30 CORPORATION ORGANIZED UNDER STATE LAW, OR THE REVOCATION OF
31 AUTHORIZATION FOR A FOREIGN CORPORATION TO CONDUCT BUSINESS IN THE
32 STATE, ON A FINDING THAT:

33 (1) THE BOARD OF DIRECTORS OR A MANAGERIAL AGENT
34 ACTING ON BEHALF OF THE CORPORATION, IN CONDUCTING AFFAIRS OF THE

1 CORPORATION, HAS AUTHORIZED OR ENGAGED IN CONDUCT IN VIOLATION OF §
2 9-804 OF THIS SUBTITLE; AND

3 (II) FOR THE PREVENTION OF FUTURE CRIMINAL ACTIVITY, THE
4 PUBLIC INTEREST REQUIRES THAT THE CHARTER OF THE CORPORATION BE
5 FORFEITED AND THAT THE CORPORATION BE DISSOLVED OR ITS AUTHORIZATION
6 TO CONDUCT BUSINESS IN THE STATE BE REVOKED.

7 (C) (1) IN AN ACTION UNDER THIS SECTION, THE COURT SHALL GRANT
8 RELIEF IN CONFORMITY WITH THE PRINCIPLES THAT GOVERN THE GRANTING OF
9 INJUNCTIVE RELIEF FROM THREATENED LOSS OR DAMAGE IN OTHER CIVIL CASES,
10 IF NO SHOWING OF SPECIAL OR IRREPARABLE DAMAGE TO THE PLAINTIFF IS MADE.

11 (2) ON THE EXECUTION OF PROPER BOND AGAINST DAMAGES FOR AN
12 INJUNCTION IMPROVIDENTLY GRANTED AND A SHOWING OF IMMEDIATE DANGER OF
13 SIGNIFICANT LOSS OR DAMAGE, THE COURT MAY ISSUE A TEMPORARY RESTRAINING
14 ORDER AND A PRELIMINARY INJUNCTION BEFORE A FINAL DETERMINATION ON THE
15 MERITS.

16 (D) A PERSON WHO IS INJURED AS A RESULT OF A VIOLATION OF § 9-804 OF
17 THIS SUBTITLE:

18 (1) HAS A CIVIL CAUSE OF ACTION AGAINST THE VIOLATOR FOR
19 THREE TIMES THE ACTUAL DAMAGES SUSTAINED AND, WHERE APPROPRIATE,
20 PUNITIVE DAMAGES; AND

21 (2) IS ENTITLED TO RECOVER ATTORNEY'S FEES IN THE TRIAL AND
22 APPELLATE COURTS AND COSTS OF INVESTIGATION AND LITIGATION REASONABLY
23 INCURRED.

24 (E) THE PLAINTIFF OR DEFENDANT MAY DEMAND A JURY TRIAL IN ANY
25 CIVIL ACTION BROUGHT UNDER THIS SECTION.

26 (F) A CRIMINAL CONVICTION FOR A VIOLATION OF § 9-804 OF THIS
27 SUBTITLE SHALL ESTOP THE DEFENDANT IN ANY SUBSEQUENT CIVIL ACTION UNDER
28 THIS SUBTITLE OR CIVIL FORFEITURE PROCEEDING UNDER TITLE 13, SUBTITLE 6
29 OF THE CRIMINAL PROCEDURE ARTICLE AS TO ALL MATTERS PROVED IN THE
30 CRIMINAL PROCEEDING.

31 (G) (1) THE APPLICATION OF ONE CIVIL REMEDY UNDER THIS SECTION
32 DOES NOT PRECLUDE THE APPLICATION OF ANY OTHER CIVIL OR CRIMINAL REMEDY
33 FOR A VIOLATION OF § 9-804 OF THIS SUBTITLE.

1 **(2) IF THE SEIZING AUTHORITY IS A UNIT OF THE STATE, A UNIT OR**
2 **PERSON THAT THE ATTORNEY GENERAL OR THE ATTORNEY GENERAL'S DESIGNEE**
3 **DESIGNATES BY AGREEMENT WITH A STATE'S ATTORNEY, COUNTY ATTORNEY, OR**
4 **MUNICIPAL ATTORNEY TO ACT ON BEHALF OF THE STATE REGARDING ASSETS**
5 **SUBJECT TO FORFEITURE BY THE STATE.**

6 **(G) "GOVERNING BODY" INCLUDES:**

7 **(1) THE STATE, IF THE SEIZING AUTHORITY IS A UNIT OF THE STATE;**

8 **(2) A COUNTY, IF THE SEIZING AUTHORITY IS A UNIT OF A COUNTY;**

9 **(3) A MUNICIPAL CORPORATION, IF THE SEIZING AUTHORITY IS A**
10 **UNIT OF A MUNICIPALITY; AND**

11 **(4) BALTIMORE CITY, IF THE SEIZING AUTHORITY IS THE BALTIMORE**
12 **POLICE DEPARTMENT.**

13 **(H) "LIEN" INCLUDES A MORTGAGE, A DEED OF TRUST, A PLEDGE, A**
14 **SECURITY INTEREST, AN ENCUMBRANCE, AND A RIGHT OF SETOFF.**

15 **(I) "LIENHOLDER" MEANS A PERSON WHO HAS A LIEN OR A SECURED**
16 **INTEREST ON PROPERTY CREATED BEFORE THE SEIZURE.**

17 **(J) "LOCAL FINANCIAL AUTHORITY" MEANS:**

18 **(1) IF THE SEIZING AUTHORITY IS A UNIT OF A COUNTY, THE**
19 **TREASURER OR DIRECTOR OF FINANCE OF THE COUNTY; OR**

20 **(2) IF THE SEIZING AUTHORITY IS A UNIT OF A MUNICIPAL**
21 **CORPORATION, THE TREASURER OR DIRECTOR OF FINANCE OF THE MUNICIPAL**
22 **CORPORATION.**

23 **(K) (1) "OWNER" MEANS A PERSON HAVING A LEGAL, EQUITABLE, OR**
24 **POSSESSORY INTEREST IN PROPERTY.**

25 **(2) "OWNER" INCLUDES:**

26 **(I) A CO-OWNER;**

27 **(II) A LIFE TENANT;**

28 **(III) A REMAINDERMAN TO A LIFE TENANCY IN REAL PROPERTY;**

1 (IV) A HOLDER OF AN INCHOATE INTEREST IN REAL PROPERTY;
2 AND

3 (V) A BONA FIDE PURCHASER FOR VALUE.

4 (L) "PROCEEDS" MEANS PROFITS DERIVED FROM A VIOLATION OF THE
5 CRIMINAL ORGANIZATIONS LAW OR PROPERTY OBTAINED DIRECTLY OR
6 INDIRECTLY FROM THOSE PROFITS.

7 (M) (1) "PROPERTY" INCLUDES:

8 (I) REAL PROPERTY AND ANYTHING GROWING ON OR
9 ATTACHED TO REAL PROPERTY;

10 (II) MOTOR VEHICLES; AND

11 (III) MONEY.

12 (2) "PROPERTY" DOES NOT INCLUDE:

13 (I) AN ITEM UNLAWFULLY IN THE POSSESSION OF A PERSON
14 OTHER THAN THE OWNER WHEN USED IN CONNECTION WITH A VIOLATION OF THE
15 CRIMINAL ORGANIZATIONS LAW; OR

16 (II) A LESSOR'S INTEREST IN PROPERTY SUBJECT TO A BONA
17 FIDE LEASE, UNLESS THE FORFEITING AUTHORITY CAN SHOW THAT THE LESSOR
18 PARTICIPATED IN A VIOLATION OF THE CRIMINAL ORGANIZATIONS LAW OR THAT
19 THE PROPERTY WAS THE PROCEEDS OF A VIOLATION OF THE CRIMINAL
20 ORGANIZATIONS LAW.

21 (N) (1) "REAL PROPERTY" MEANS LAND OR AN IMPROVEMENT TO LAND.

22 (2) "REAL PROPERTY" INCLUDES:

23 (I) A LEASEHOLD OR ANY OTHER LIMITED INTEREST IN
24 PROPERTY;

25 (II) AN EASEMENT; AND

26 (III) A REVERSIONARY INTEREST IN A 99-YEAR GROUND LEASE
27 RENEWABLE FOREVER.

1 (O) "SEIZING AUTHORITY" MEANS A LAW ENFORCEMENT UNIT IN THE
2 STATE THAT IS AUTHORIZED TO INVESTIGATE VIOLATIONS OF THE CRIMINAL
3 ORGANIZATIONS LAW AND THAT HAS SEIZED PROPERTY UNDER THIS SUBTITLE.

4 13-602.

5 THE FOLLOWING ARE SUBJECT TO FORFEITURE:

6 (1) EXCEPT AS PROVIDED IN § 13-603 OF THIS SUBTITLE, A MOTOR
7 VEHICLE USED IN CONNECTION WITH A VIOLATION OF AND CONVICTION UNDER §
8 9-804 OF THE CRIMINAL LAW ARTICLE;

9 (2) MONEY USED IN CONNECTION WITH A VIOLATION OF AND
10 CONVICTION UNDER THE CRIMINAL ORGANIZATIONS LAW, FOUND IN CLOSE
11 PROXIMITY TO OR AT THE SCENE OF THE ARREST FOR A VIOLATION OF THE
12 CRIMINAL ORGANIZATIONS LAW; AND

13 (3) EXCEPT AS PROVIDED IN § 13-603 OF THIS SUBTITLE, REAL
14 PROPERTY USED IN CONNECTION WITH A VIOLATION OF AND CONVICTION UNDER §
15 9-804 OF THE CRIMINAL LAW ARTICLE.

16 13-603.

17 (A) PROPERTY OR AN INTEREST IN PROPERTY DESCRIBED IN § 13-602(1)
18 OR (3) OF THIS SUBTITLE MAY NOT BE FORFEITED IF THE OWNER ESTABLISHES BY
19 A PREPONDERANCE OF THE EVIDENCE THAT THE VIOLATION OF THE CRIMINAL
20 ORGANIZATIONS LAW WAS COMMITTED WITHOUT THE OWNER'S ACTUAL
21 KNOWLEDGE.

22 (B) (1) A MOTOR VEHICLE FOR HIRE IN THE TRANSACTION OF BUSINESS
23 AS A COMMON CARRIER OR A MOTOR VEHICLE FOR HIRE MAY NOT BE SEIZED OR
24 FORFEITED UNDER THIS SUBTITLE UNLESS IT APPEARS THAT THE OWNER OR OTHER
25 PERSON IN CHARGE OF THE MOTOR VEHICLE WAS A CONSENTING PARTY OR PRIVY
26 TO A VIOLATION OF THE CRIMINAL ORGANIZATIONS LAW.

27 (2) A MOTOR VEHICLE MAY NOT BE FORFEITED UNDER THIS
28 SUBTITLE FOR AN ACT OR OMISSION THAT THE OWNER SHOWS WAS COMMITTED OR
