- 3 (a) Unless the Board agrees to accept the surrender of a license, a licensed social worker **OR THE HOLDER OF A TEMPORARY LICENSE** may not surrender the license nor may the license lapse by operation of law while the licensee is under investigation or while charges are pending against the social worker.
- 7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 2023.
