A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Annual Education Budget – Required Information**

3 FOR the purpose of requiring the Anne Arundel County Board of Education to include
4 certain additional information in its annual budget under certain
5 circumstances; making certain conforming changes; and generally relating to
6 the annual budget of the Anne Arundel County Board of Education.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article – Education**

20 5–101.

21 (a) (1) Subject to the rules and regulations of the State Board and with
22 the advice of the county superintendent, each county board shall prepare an annual
23 budget according to:

24 (i) The major categories listed in this section; and

1 (ii) Any other major category required by the State Board.

2 (c) In **ANNE ARUNDEL COUNTY AND MONTGOMERY COUNTY**, IN
 3 addition to all other information required by this section, the [Montgomery County
 4 Board of Education] **COUNTY BOARD**, on request of the [County Executive] **COUNTY**
 5 **EXECUTIVE** and [County Council] **COUNTY COUNCIL**, shall provide with the annual
 6 budget the program implications of recommendations for reductions to or increases in
 7 its annual budget, at whatever different levels of funding and accompanied by
 8 whatever reasonable supporting detail and analysis, as may be specified by the
 9 [County Executive] **COUNTY EXECUTIVE** and [County Council] **COUNTY COUNCIL**.
 10 Prior to the submission of the annual budget, similar information shall be submitted
 11 by the [Superintendent of Schools] **COUNTY SUPERINTENDENT** upon request by the
 12 [County Executive] **COUNTY EXECUTIVE** or [County Council] **COUNTY COUNCIL**.

13 (e) In addition to all other information required by this section, the Cecil
 14 County Board of Education, on request of the Cecil County Board of Estimates, **AND**
 15 **THE ANNE ARUNDEL COUNTY BOARD OF EDUCATION, ON REQUEST OF THE**
 16 **COUNTY EXECUTIVE AND COUNTY COUNCIL**, shall provide with the annual budget
 17 separate information on the number of and costs associated with school-based
 18 noninstructional personnel.

19 (f) (1) In **ANNE ARUNDEL COUNTY AND PRINCE GEORGE'S COUNTY**,
 20 **IN** addition to all other information required by this section, the [Prince George's
 21 County Board of Education] **COUNTY BOARD** shall provide to the [County Executive]
 22 **COUNTY EXECUTIVE** and [County Council] **COUNTY COUNCIL** with the annual
 23 budget, information relating to each of the following categories:

24 (i) Instructional supplies and materials;

25 (ii) Additional equipment; and

26 (iii) Replacement equipment.

27 (2) For the categories specified in paragraph (1) of this subsection, the
 28 following information shall be provided for the public school system in the county:

29 (i) Proposed expenditures for the next school year based on the
 30 annual budget;

31 (ii) Estimated expenditures for the current school year; and

32 (iii) Actual expenditures for the prior school year.

33 **SECTION 2. AND BE IT FURTHER ENACTED**, That this Act shall take effect
 34 July 1, 2011.
