1 AN ACT concerning

Vehicle Laws - Licenses, Identification Cards, and Moped Operator's Permits Indication of Applicant's Sex

- 4 FOR the purpose of requiring that an application for a license, an identification card, or a moped operator's permit allow an applicant to indicate the applicant's sex in a 5 certain manner; requiring the Motor Vehicle Administration to ensure that the 6 7 license, identification card, or moped operator's permit of an applicant who indicates 8 that the applicant's sex is unspecified displays a certain notation in the location that 9 indicates the applicant's sex; prohibiting the Administration from requiring a certain 10 applicant to provide proof of the applicant's sex; prohibiting the Administration from denying a certain application under certain circumstances; and generally relating to 11 licenses, identification cards, and moped operator's permits. 12
