 fire drill in each public school [at least 10 times each school year and at least once every 60
 days] IN ACCORDANCE WITH THE STATE FIRE PREVENTION CODE ESTABLISHED
 UNDER § 6–206 OF THE PUBLIC SAFETY ARTICLE.
