(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED. "ATTENDING PHYSICIAN" MEANS THE LICENSED PHYSICIAN WHO HAS (B) PRIMARY RESPONSIBILITY FOR THE MEDICAL CARE OF AN INDIVIDUAL.

"HEALTH CARE FACILITY" MEANS A FACILITY OR AN OFFICE WHERE
