THE PURPOSE OF THE FUND IS TO RECEIVE REVENUE FROM ASSISTIVE 1 (B) 2 TECHNOLOGY SERVICES PROVIDED BY THE PROGRAM, INCLUDING: 3 **(1)** ASSISTIVE TECHNOLOGY ASSESSMENTS; **(2)** 4 ASSISTIVE TECHNOLOGY TRAINING; **(3)** 5 DIGITAL ACCESSIBILITY TRAINING; 6 **(4)** DIGITAL ACCESSIBILITY WEBSITE EVALUATIONS; AND 7 **(5)** DIGITAL ACCESSIBILITY REMEDIATION SERVICES.
