A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2011 – Frederick County –**
3 **Frederick Alliance For Youth – Youth and Community Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2011
5 to alter the grantee and the purpose of a certain grant to allow the grant to be
6 used for a certain building; altering the deadline for a certain grantee to present
7 evidence of a certain matching fund and to encumber funds for a certain grant;
8 and generally relating to amending the Maryland Consolidated Capital Bond
9 Loan of 2011.

10 BY repealing and reenacting, with amendments,
11 Chapter 396 of the Acts of the General Assembly of 2011
12 Section 1(3) Item ZA02(AL) and Item ZA03(AG)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:
