- 7 1. the gift would give the appearance of impairing the 8 impartiality and independent judgment of the official or employee; or

- 31 (a) A statement that is required under § 5–601(a) of this subtitle shall contain 32 schedules disclosing the information and interests specified in this section, if known, for 33 the individual making the statement for the applicable period.
