A BILL ENTITLED

1 AN ACT concerning

2 **Domestic Partnership and Marriage – Required Information**

3 FOR the purpose of clarifying certain requirements for registering a domestic partnership
4 or obtaining a marriage license; requiring a declaration of domestic partnership filed
5 with a register of wills to include the Social Security number of each domestic
6 partner who has a Social Security number; and generally relating to domestic
7 partnership and marriage.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Estates and Trusts**

21 2–214.

22 (a) (1) Subject to the requirements of paragraph (2) of this subsection, two
23 individuals may register a domestic partnership by filing a declaration of domestic
24 partnership with the register of wills in the county in which the domestic partners are
25 domiciled.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 (2) A declaration of domestic partnership filed with the register of wills
2 shall:

3 (i) Include:

- 4 1. The full **LEGAL** name of each domestic partner;
- 5 2. The home address of each domestic partner; [and]
- 6 3. The [age] **DATE OF BIRTH** of each domestic partner; **AND**
- 7 4. **THE SOCIAL SECURITY NUMBER OF EACH PARTY WHO**
8 **HAS A SOCIAL SECURITY NUMBER;**

9 (ii) Be signed directly by each party, or by another individual, at the
10 express direction of the party and in the party's presence;

11 (iii) Be signed in the physical presence of a notary public or before a
12 notary public through communication technology in accordance with Title 18, Subtitle 2 of
13 the State Government Article; and

14 (iv) Affirm under penalty of perjury that each domestic partner is:

- 15 1. At least 18 years old;
- 16 2. The sole domestic partner of the other;
- 17 3. Not married; and
- 18 4. In a committed relationship with the other individual.

19 (d) (1) The register shall maintain adequate records of declarations of
20 domestic partnership, amendments to declarations of domestic partnership, and
21 termination statements.

22 (2) Except as provided in [paragraph (3)] **PARAGRAPHS (3) AND (4)** of
23 this subsection, a declaration of domestic partnership filed with a register of wills is a public
24 record.

25 (3) The register shall deny inspection of the part of a declaration of
26 domestic partnership that contains the home address of either domestic partner.

27 **(4) EXCEPT AS PROVIDED IN § 4-334 OF THE GENERAL PROVISIONS**
28 **ARTICLE, THE SOCIAL SECURITY NUMBER OF A PARTY MAY NOT BE DISCLOSED AS**
29 **PART OF THE PUBLIC RECORD OF THE DECLARATION OF DOMESTIC PARTNERSHIP.**

3 (a) An applicant for a license may apply to the clerk only at the office of the clerk
4 during regular office hours.

5 (b) Except as provided in subsection (d) of this section, to apply for a license, [1]
6 **ONE** of the parties to be married shall:

7 (1) appear before the clerk and give, under oath, the following information,
8 which shall be placed on an application form by the clerk:

9 (i) the full **LEGAL** name of each party;

10 (ii) the place of residence of each party;

11 (iii) the [age] **DATE OF BIRTH** of each party;

12 (iv) whether the parties are related by blood or marriage and, if so,
13 in which degree of relationship;

14 (v) the marital status of each party; and

15 (vi) whether either party was married previously, and the date and
16 place of each death or judicial determination that ended any former marriage;

17 (2) sign the application form; and

18 (3) provide the clerk with:

19 (i) the Social Security number of each party who has a Social
20 Security number; and

21 (ii) a copy of an official government–issued birth certificate or other
22 official government–issued document or record demonstrating the age of each party.

23 (c) The Social Security numbers of the parties:

24 (1) shall be included in the electronic file for the marriage license
25 application; and

26 (2) except as provided in § 4–334 of the General Provisions Article, may not
27 be disclosed as part of the public record of the marriage license application.

1 (d) **(1)** If the parties to be married are not residents of the county where the
2 marriage ceremony is to be performed, the clerk shall accept, instead of the application
3 specified in subsection (b) of this section, an affidavit from **[1] ONE** of the parties to be
4 married.

5 **(2)** The affidavit **REQUIRED UNDER PARAGRAPH (1) OF THIS**
6 **SUBSECTION** shall:

7 **[(1)] (I)** contain the information required by subsection (b) of this section;
8 and

9 **[(2)] (II)** be sworn to under oath before a clerk or other comparable official
10 in the county, state, province, or country where the party resides.

11 (e) Until a license becomes effective, a clerk may not disclose the fact that an
12 application for a license has been made except to the parent or guardian of a party to be
13 married.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2025.
