A BILL ENTITLED

1 AN ACT concerning

2 **Howard County – Sheriff – Salary Increase**

3 FOR the purpose of increasing the annual salary of the Sheriff of Howard County to a
4 certain amount over a certain time period; providing that this Act does not
5 apply to the salary or compensation of the incumbent Sheriff during a certain
6 term of office; and generally relating to the salary of the Sheriff of Howard
7 County.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Courts and Judicial Proceedings**

16 2–309.

17 (o) (1) (i) The Sheriff of Howard County shall receive an annual salary
18 as follows:

- 19 [1. \$65,000 for calendar year 2005;
20 2. \$66,500 for calendar year 2006;
21 3. \$77,500 for calendar year 2007;

- 1 4. \$80,000 for calendar year 2008;
- 2 5. \$82,500 for calendar year 2009; and
- 3 6. \$85,000 for calendar year 2010.]
- 4 **1. \$85,000 FOR CALENDAR YEAR 2013;**
- 5 **2. \$85,000 FOR CALENDAR YEAR 2014;**
- 6 **3. \$87,500 FOR CALENDAR YEAR 2015;**
- 7 **4. \$90,000 FOR CALENDAR YEAR 2016;**
- 8 **5. \$92,500 FOR CALENDAR YEAR 2017; AND**
- 9 **6. \$95,000 FOR CALENDAR YEAR 2018.**

10 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §
11 35 of the Maryland Constitution, this Act may not be construed to extend or apply to
12 the salary or compensation of the Sheriff of Howard County during a term of office
13 beginning before the effective date of this Act, but the provisions of this Act concerning
14 the salary or compensation of the Sheriff of Howard County shall take effect at the
15 beginning of the next following term of office.

16 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2013.
