18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

3 Maryland Community College Promise Scholarship award.

4 (2) The Office annually shall select eligible applicants and offer a Maryland
5 Community College Promise Scholarship award to each selected applicant to be used for
6 tuition at a community college of the applicant's choice.

7 (b) An applicant is eligible for a Maryland Community College Promise

 3 ineligible to receive an award under this subtitle.
