## Department of Planning – State Repository and Clearinghouse for Federal and State Financial and Technical Assistance

- 4 FOR the purpose of repealing a requirement that the Department of Planning serve as a 5 repository and clearinghouse for information concerning federal and State grants, 6 loans, and other financial and technical assistance; repealing a requirement that the 7 Department adopt certain regulations requiring units of State government to submit 8 certain information to the Department and publish certain information in the 9 Maryland Register; altering a requirement that the Department publish certain 10 information concerning State financial and technical assistance offered through State assistance programs; and generally relating to the Department of Planning 11 12 and information concerning certain financial and technical assistance.
