#### 1 AN ACT concerning

# Montgomery County - Alcoholic Beverages - Special BWL Community Performing Arts Facility License

4 FOR the purpose of establishing a Special BWL Community Performing Arts Facility  $\mathbf{5}$ alcoholic beverages license in Montgomery County; authorizing the Montgomery 6 County Board of License Commissioners to issue a Special BWL Community 7 Performing Arts Facility license to apply to a certain performing arts facility; 8 authorizing the Board to issue the license to certain entities to host certain 9 activities; authorizing the Board to impose certain conditions on the issuance or renewal of the license; prohibiting the Board from approving the transfer of the 10 license to another location; authorizing holders of certain catering licenses to 11 12bring alcohol and food onto certain licensed premises under the terms of a 13 certain contract; providing that certain violations of alcoholic beverages law 14apply to a certain caterer under certain circumstances; requiring a holder of the license to ensure that food is provided during a certain time; prohibiting the 1516 Board from issuing more than a certain number of licenses under this Act to a 17certain entity; establishing a certain license fee; defining a certain term; and 18 generally relating to alcoholic beverages licenses in Montgomery County.

5	(q) (1) (i) This subsection applies only in Montgomery County.

$12 \\ 13 \\ 14 \\ 15$	(5) (I) IN THIS PARAGRAPH, "COMMUNITY PERFORMING ARTS FACILITY" MEANS A FACILITY THAT IS USED FOR SHOWS, LIVE PERFORMANCES, THEATER PRODUCTIONS, ART CLASSES, EXHIBITS, VISUAL ART SHOWS, WEDDINGS, BANQUETS, AND COMMUNITY-RELATED ACTIVITIES.

18 19 20 21	(III) THE BOARD MAY ISSUE A SPECIAL BWL COMMUNITY PERFORMING ARTS FACILITY LICENSE TO APPLY ONLY TO A PERFORMING ARTS FACILITY THAT HAS A MINIMUM CAPACITY OF 200 PERSONS AND A MAXIMUM CAPACITY OF 1,499 PERSONS.

26 27 28	(V) 1. THE LICENSE AUTHORIZES THE HOLDER TO SELL BEER, WINE, AND LIQUOR BY THE DRINK FROM ONE OR MORE OUTLETS ON THE LICENSED PREMISES FOR CONSUMPTION ON THE LICENSED PREMISES.
29 30 31	2. A HOLDER OF THE LICENSE MAY EXERCISE THE PRIVILEGES UNDER THE LICENSE FROM 10 A.M. ON ANY DAY UNTIL 2 A.M. THE FOLLOWING DAY.

1 (VI) THE BOARD MAY IMPOSE CONDITIONS ON THE 2 ISSUANCE OR RENEWAL OF THE LICENSE THAT ESTABLISH THE AREAS IN THE 3 COMMUNITY PERFORMING ARTS FACILITY WHERE BEER, WINE, AND LIQUOR 4 MAY BE SOLD, SERVED, POSSESSED, OR CONSUMED.

5 (VII) THE BOARD MAY NOT APPROVE THE TRANSFER OF THE 6 LICENSE TO ANOTHER LOCATION.

7 (VIII) 1. A HOLDER OF A CLASS B-BWLHR LICENSE WITH 8 CATERING AUTHORITY, A MONTGOMERY COUNTY CATERING LICENSE (CAT), 9 OR A STATEWIDE CATERER LICENSE (SCAT) MAY BRING ALCOHOL AND FOOD 10 ON THE LICENSED PREMISES UNDER THE TERMS OF A CONTRACT WITH A 11 HOLDER OF A SPECIAL BWL COMMUNITY PERFORMING ARTS FACILITY 12 LICENSE.

13 2. A VIOLATION OF THIS ARTICLE THAT OCCURS
14 WHEN A CATERER BRINGS ALCOHOL ON LICENSED PREMISES AS PROVIDED
15 UNDER SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH IS THE RESPONSIBILITY
16 OF THE CATERER AND IS NOT THE RESPONSIBILITY OF THE HOLDER OF THE
17 LICENSE.

18 (IX) A HOLDER OF THE LICENSE SHALL ENSURE THAT FOOD
 19 IS PROVIDED DURING THE HOURS ALCOHOLIC BEVERAGES ARE SOLD, SERVED,
 20 POSSESSED, OR CONSUMED.

21(x) THE BOARD MAY ISSUE NO MORE THAN THREE22LICENSES TO A NOT-FOR-PROFIT PARTNERSHIP, A LIMITED LIABILITY23COMPANY, A CORPORATION, OR ANY OTHER ENTITY THAT OWNS OR LEASES24PERFORMING ARTS FACILITIES IN SEPARATE LOCATIONS.

25 (XI) THE ANNUAL LICENSE FEE IS \$750.

#### 26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 27 July 1, 2014.
