A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore County Board of Education – Nonstudent Member Compensation and**
3 **Student Member Scholarships – Alterations**

4 FOR the purpose of altering the annual compensation of certain nonstudent members of
5 the Baltimore County Board of Education; providing that the chair of the county
6 board is entitled to a certain annual compensation; altering the amount that a
7 student member of the board is granted for a certain scholarship; and generally
8 relating to annual compensation and scholarship amounts for members of the
9 Baltimore County Board of Education.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Education**

23 3–2B–01.

24 (a) The Baltimore County Board of Education consists of:

1 (1) Seven nonpartisan elected members;

2 (2) Four appointed members; and

3 (3) One student member.

5 (a) (1) **(I)** Each nonstudent member of the county board **WHO IS NOT THE**
6 **CHAIR OF THE COUNTY BOARD** is entitled to receive **[\$7,500] \$16,500** annually as
7 compensation.

8 **(II) THE CHAIR OF THE COUNTY BOARD IS ENTITLED TO**
9 **RECEIVE \$17,500 ANNUALLY AS COMPENSATION.**

10 (2) A student member who completes a full term on the county board shall
11 be granted a scholarship of **[\$7,500] \$10,000** to be applied toward the student's higher
12 education costs.

13 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35
14 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary
15 or compensation of the nonstudent members of the Baltimore County Board of Education
16 or the scholarship amount for the student member of the Baltimore County Board of
17 Education while serving in a term of office beginning before the effective date of this Act,
18 but the provisions of this Act concerning the salary or compensation of the nonstudent
19 members of the Baltimore County Board of Education and the scholarship amount for the
20 student member of the Baltimore County Board of Education shall take effect at the
21 beginning of the next following term of office. This limitation does not apply to an individual
22 appointed or elected after the effective date of this Act to fill out an unexpired term.

23 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2024.
