## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2009 – Charles County –**  
3 **Hospice House**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2009  
5 to authorize the matching fund for a certain grant to the Board of Directors of  
6 the Hospice of Charles County, Inc. to consist of real property.

7 BY repealing and reenacting, with amendments,  
8 Chapter 485 of the Acts of the General Assembly of 2009  
9 Section 1(3) Item ZA02(AB) and ZA03(AE)

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
11 MARYLAND, That the Laws of Maryland read as follows:

12 **Chapter 485 of the Acts of 2009**

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That:

16 (AB) Hospice House. Provide a grant equal to the lesser of (i)  
17 \$105,000 or (ii) the amount of the matching fund provided, to  
18 the Board of Directors of the Hospice of Charles County, Inc.  
19 for the acquisition, planning, design, construction, and capital  
20 equipping of a residential hospice house, located in La Plata.  
21 Notwithstanding Section 1(5) of this Act, the matching fund  
22 may consist of **REAL PROPERTY AND** in kind contributions  
23 (Charles County) ..... 105,000
