CHAPTER _____

1 AN ACT concerning

2 **Prince George's County Public Schools – Funding Accountability and**
3 **Transparency Act**

4 FOR the purpose of requiring the Prince George's County Board of Education to
5 develop and operate a certain Web site that includes certain information about
6 certain payments; specifying certain parameters of the Web site; defining
7 certain terms; and generally relating to the development and operation of a
8 searchable Web site by the Prince George's County Board of Education.

9 BY adding to
10 Article – Education
11 Section 5–117
12 Annotated Code of Maryland
13 (2008 Replacement Volume and 2010 Supplement)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Education**

17 **5–117.**

18 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE**
19 **MEANINGS INDICATED.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.

Underlining indicates amendments to bill.

~~Strike out~~ indicates matter stricken from the bill by amendment or deleted from the law by amendment.



1 **(2) (I) “PAYEE” MEANS ANY PARTY WHO RECEIVES FROM THE**
2 **PRINCE GEORGE’S COUNTY BOARD OF EDUCATION AN AGGREGATE PAYMENT**
3 **OF \$25,000 IN A FISCAL YEAR.**

4 **(II) “PAYEE” DOES NOT INCLUDE:**

5 **1. A PRINCE GEORGE’S COUNTY PUBLIC SCHOOL**
6 **EMPLOYEE WITH RESPECT TO THE EMPLOYEE’S COMPENSATION; OR**

7 **2. A PRINCE GEORGE’S COUNTY PUBLIC SCHOOL**
8 **RETIREE WITH RESPECT TO THE RETIREE’S RETIREMENT ALLOWANCE.**

9 **(3) “SEARCHABLE WEB SITE” MEANS A WEB SITE CREATED IN**
10 **ACCORDANCE WITH THIS SECTION THAT DISPLAYS AND SEARCHES PAYMENT**
11 **DATA OF THE PRINCE GEORGE’S COUNTY BOARD OF EDUCATION.**

12 **(B) ON OR BEFORE JANUARY 1, 2013, THE PRINCE GEORGE’S COUNTY**
13 **BOARD OF EDUCATION SHALL DEVELOP AND OPERATE A SINGLE SEARCHABLE**
14 **WEB SITE ACCESSIBLE TO THE PUBLIC AT NO COST THROUGH THE INTERNET.**

15 **(C) THE SEARCHABLE WEB SITE SHALL CONTAIN PRINCE GEORGE’S**
16 **COUNTY BOARD OF EDUCATION PAYMENT DATA INCLUDING:**

17 **(1) THE NAME OF A PAYEE RECEIVING A PAYMENT;**

18 **(2) THE LOCATION OF A PAYEE BY ZIP CODE; AND**

19 **(3) THE AMOUNT OF A PAYMENT.**

20 **(D) THE SEARCHABLE WEB SITE SHALL ALLOW THE USER TO:**

21 **(1) SEARCH DATA FOR FISCAL YEAR 2012 AND EACH FISCAL YEAR**
22 **THEREAFTER; AND**

23 **(2) SEARCH BY THE FOLLOWING DATA FIELDS:**

24 **(I) A PAYEE RECEIVING A PAYMENT; AND**

25 **(II) THE ZIP CODE OF A PAYEE RECEIVING A PAYMENT.**

26 **(E) THIS SECTION MAY NOT BE CONSTRUED TO REQUIRE THE**
27 **DISCLOSURE OF INFORMATION THAT IS CONFIDENTIAL UNDER FEDERAL,**
28 **STATE, OR LOCAL LAW.**

1 (F) THIS SECTION SHALL BE KNOWN AND MAY BE CITED AS THE
2 “PRINCE GEORGE’S COUNTY PUBLIC SCHOOLS FUNDING ACCOUNTABILITY
3 AND TRANSPARENCY ACT”.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 July 1, 2011.
