## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **General Assembly – Committee Chairs and Vice Chairs – Gender-Neutral**  
3 **Language**

4 FOR the purpose of altering certain terminology that refers to chairs and vice chairs of  
5 committees of the General Assembly to be gender-neutral; and generally relating to  
6 chairs and vice chairs of committees of the General Assembly.

7 BY repealing and reenacting, with amendments,

8 Article – State Government

9 Section 2–403(a), 2–404, 2–405(b), 2–406(b)(1), 2–504, 2–604, 2–704(a), 2–804,  
10 2–805(b), 2–904, 2–1003(a)(2) and (b), 2–10A–01(d), 2–10A–06(f),  
11 2–1224(d)(2), 2–1258(a)(2), 2–1505(c)(2) and (f), 2–1605, and 2–1609(h)(2)(v)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
15 That the Laws of Maryland read as follows:

16 **Article – State Government**

17 2–403.

18 (a) The Legislative Policy Committee consists of the following 28 members:

19 (1) from the Senate:

- 2 (ii) the President Pro Tem;
- 3 (iii) the Majority Leader;
- 4 (iv) the [Chairman] **CHAIR** of the Budget and Taxation Committee;
- 5 (v) the [Chairman] **CHAIR** of the [Education, Health, and  
6 Environmental Affairs Committee] **COMMITTEE ON EDUCATION, ENERGY, AND THE**  
7 **ENVIRONMENT**;
- 8 (vi) the [Chairman] **CHAIR** of the Finance Committee;
- 9 (vii) the [Chairman] **CHAIR** of the Judicial Proceedings Committee;
- 10 (viii) the Minority Leader; and
- 11 (ix) 1. 6 other Senators, appointed by the President and approved  
12 by majority vote of the Senate; or
- 13 2. if a Senator simultaneously serves in 2 of the positions set  
14 forth in items (ii) through (vii), inclusive, of this [paragraph] **ITEM**, 7 other Senators,  
15 appointed by the President and approved by majority vote of the Senate; and
- 16 (2) from the House:
- 17 (i) the Speaker;
- 18 (ii) the Speaker Pro Tem;
- 19 (iii) the Majority Leader;
- 20 (iv) the [Chairman] **CHAIR** of the Appropriations Committee;
- 21 (v) the [Chairman] **CHAIR** of the Health and Government  
22 Operations Committee;
- 23 (vi) the [Chairman] **CHAIR** of the Economic Matters Committee;
- 24 (vii) the [Chairman] **CHAIR** of the Environment and Transportation  
25 Committee;
- 26 (viii) the [Chairman] **CHAIR** of the Judiciary Committee;

1 (ix) the [Chairman] **CHAIR** of the Ways and Means Committee;

2 (x) the Minority Leader; and

3 (xi) 1. 4 other Delegates, appointed by the Speaker and approved  
4 by majority vote of the House; or

5 2. if a Delegate simultaneously serves in 2 of the positions  
6 set forth in items (ii) through (ix), inclusive, of this [paragraph] **ITEM**, 5 other Delegates,  
7 appointed by the Speaker and approved by majority vote of the House.

9 The President and the Speaker are [cochairmen] **COCHAIRS** of the Committee.

10 2–405.

11 (b) (1) If a vacancy occurs in one of the offices of [cochairmen] **COCHAIRS** of  
12 the Committee, a successor shall be elected:

13 (i) for the Senate [cochairman] **COCHAIR**, by the Senators on the  
14 Committee; and

15 (ii) for the House [cochairman] **COCHAIR**, by the Delegates on the  
16 Committee.

17 (2) If vacancies occur in both offices of the [cochairmen] **COCHAIRS** of the  
18 Committee, the successors shall be elected from among the remaining members of the  
19 Committee by those members. One of the [cochairmen] **COCHAIRS** shall be a Senator, and  
20 one shall be a Delegate.

22 (b) (1) The Committee shall meet as often as necessary, at the times and places  
23 that its [cochairmen] **COCHAIRS** determine.

24 2–504.

25 The Senate [Chairman] **CHAIR** and the House [Chairman] **CHAIR** of the Committee  
26 shall be appointed by the President and the Speaker, respectively, from the membership of  
27 the Committee. One shall be a Senator appointed by the President, and the other shall be  
28 a Delegate appointed by the Speaker. The presiding [chairmanship] **CHAIRSHIP** and  
29 [cochairmanship] **COCHAIRSHIP** shall be alternated annually between the Senate and the  
30 House.

31 2–604.

1 The President and the Speaker jointly shall appoint the [chairman] CHAIR and the  
2 vice [chairman] CHAIR of the Committee.

3 2-704.

4 (a) The President and the Speaker:

5 (1) jointly shall appoint a [chairman] CHAIR and a vice [chairman] CHAIR  
6 of the Committee; or

7 (2) each shall appoint a [cochairman] COCHAIR of the Committee.

8 2-804.

9 The President and the Speaker jointly shall appoint the [chairman] CHAIR and the  
10 vice [chairman] CHAIR of the Committee.

11 2-805.

12 (b) The Committee shall meet:

13 (1) at the times and places that it determines; and

14 (2) at the call of its [chairman] CHAIR or, if the [chairman] CHAIR is  
15 absent, at the call of its vice [chairman] CHAIR.

16 2-904.

17 (a) The President and the Speaker jointly shall appoint a [chairman] CHAIR and  
18 a vice [chairman] CHAIR of the Committee.

19 (b) (1) The President shall appoint a [chairman] CHAIR of the Senate  
20 members of the Committee.

21 (2) The Speaker shall appoint a [chairman] CHAIR of the House members  
22 of the Committee.

23 2-1003.

24 (a) On or before June 1 of each year, the Legislative Policy Committee shall create  
25 a Spending Affordability Committee comprised of an equal number of Senators and  
26 Delegates. The Committee membership includes:

27 (2) the [chairmen] CHAIRS of the Senate Budget and Taxation Committee  
28 and the House Appropriations Committee;

1 (b) The [chairman] **CHAIR** of the Committee shall be designated jointly by the  
2 President and the Speaker.

3 2-10A-01.

4 (d) The President and the Speaker shall jointly appoint a Senator and a Delegate  
5 each to serve as [cochairman] **COCHAIRS**.

6 2-10A-06.

7 (f) (1) From among the membership of the Committee, the President shall  
8 appoint a Senator to serve as the Senate [chairman] **CHAIR** of the Committee and the  
9 Speaker shall appoint a Delegate to serve as the House [chairman] **CHAIR** of the  
10 Committee.

11 (2) The Senate [chairman] **CHAIR** and the House [chairman] **CHAIR** shall  
12 alternate annually as presiding [chairman] **CHAIR** and [cochairman] **COCHAIR** of the  
13 Committee.

15 (d) The Legislative Auditor shall send a copy of the report to:

16 (2) the [Chairmen] **CHAIRS** of the Senate Budget and Taxation and House  
17 Appropriations Committees;

18 2-1258.

19 (a) (2) On request, the Department shall provide one additional copy of an  
20 annotated code of Maryland to each:

21 (i) presiding officer;

22 (ii) pro tempore officer;

23 (iii) [chairman] **CHAIR** of a standing committee;

24 (iv) majority leader; and

25 (v) minority leader.

27 (c) (2) If the [chairman] **CHAIR** of the committee to which a bill is referred  
28 certifies that prompt committee action on the bill is needed to conduct legislative business

1 and, before the Department prepares the fiscal note for the bill, holds a hearing on the bill,  
2 the Department shall prepare the note as soon after the hearing as possible.

3 (f) As soon as possible after the adoption of an amendment that changes the fiscal  
4 impact of a bill, the Department of Legislative Services shall:

5 (1) prepare a revised fiscal note for the bill; and

6 (2) send the revised note:

7 (i) to the [chairman] **CHAIR** of the committee to which the bill is  
8 referred in the house of origin;

9 (ii) if the bill has reached the opposite house, to the [chairman]  
10 **CHAIR** of the committee to which the bill is referred in that house;

11 (iii) if the bill is in the custody of either the Secretary of the Senate  
12 or the Chief Clerk of the House, to that officer; and

13 (iv) to the primary sponsor of the bill.

14 2–1605.

15 (a) An investigating committee shall have the [chairman and vice chairman]  
16 **CHAIR AND VICE CHAIR** who:

17 (1) are appointed by the resolution that establishes the investigating  
18 committee; or

19 (2) if the resolution does not appoint these officers, are elected by  
20 affirmative vote of a majority of all of the members of the investigating committee.

21 (b) The rules of an investigating committee shall provide for the selection of a  
22 presiding officer to act if the [chairman and vice chairman] **CHAIR AND VICE CHAIR** are  
23 absent or unable to act.

24 (c) (1) At a hearing of an investigating committee, the presiding officer shall  
25 be:

26 (i) the [chairman] **CHAIR** of the investigating committee;

27 (ii) if the [chairman] **CHAIR** is absent or otherwise unable to preside,  
28 the vice [chairman] **CHAIR**; or

29 (iii) if the [chairman and vice chairman] **CHAIR AND VICE CHAIR**  
30 are absent or otherwise unable to preside, the individual who is selected under the rules of

1 the investigating committee.

2 (2) At a hearing, the presiding officer:

3 (i) shall examine the witnesses or supervise the examination by any  
4 other member of the investigating committee or by staff who are authorized to examine  
5 witnesses; and

6 (ii) may direct a witness to answer a relevant question or to provide  
7 a relevant book, document, or paper.

9 (h) (2) The record shall include:

10 (v) any other matter that the investigating committee or its  
11 [chairman] CHAIR directs.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
13 1, 2024.
