## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Anne Arundel County – Special Taxing Districts – Exemptions**

3 FOR the purpose of providing that certain taxes, or assessments, ~~fees, or charges~~ imposed  
4 by Anne Arundel County in certain special taxing districts do not apply to certain  
5 property that is exempt from taxation; and generally relating to special taxing  
6 districts in Anne Arundel County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

1 (a) The County Council of Anne Arundel County may impose a direct tax on  
2 property in a shore erosion control district to:

3 (1) repay a loan made to the county by the State under § 8–1005 of the  
4 Natural Resources Article for the construction of an erosion control project for the benefit  
5 of a shore erosion control district; and

6 (2) pay for maintenance, repair, and reconstruction of erosion control  
7 projects.

8 (b) A tax under this section [shall]:

9 (1) **SHALL** be imposed and collected as county taxes are imposed and  
10 collected; [and]

11 (2) **SHALL** have the same priority rights, bear the same interest and  
12 penalties, and in every respect be treated the same as county taxes; **AND**

13 **(3) MAY NOT APPLY TO PROPERTY THAT IS EXEMPT FROM TAXATION**  
14 **UNDER TITLE 7, SUBTITLE 2 OF THE TAX – PROPERTY ARTICLE.**
