## Baltimore City Soil Conservation District - Establishment - Requirements

- 3 FOR the purpose of providing for the establishment of a Baltimore City Soil Conservation
- 4 District; adding Baltimore City to a geographic area from which the Secretary of
- 5 Agriculture appoints the soil conservation district supervisors; requiring the Mayor
- 6 of Baltimore City to take certain actions to form the District; requiring the Secretary
- of State to take certain actions to record the organization of the District; providing
- 8 for the appointment of the supervisors for the District; and generally relating to the
- 9 establishment of a Baltimore City Soil Conservation District.

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 21 That the Laws of Maryland read as follows:

- 1 (a) In [this subtitle] SUBTITLES 1 THROUGH 4 OF THIS TITLE the following 2 words have the meanings indicated.
- 3 (b) "Committee" means the State Soil Conservation Committee.
- 4 (c) "Conservation" means the wise utilization of natural resources and includes 5 any one or more of the following: [the]
- 6 (1) THE development, improvement, maintenance, protection or 7 preservation of these resources; [the]
- 8 **(2)** THE control and prevention of flood water and sediment damage; and 9 [the]
- 10 **(3) THE** every county of the State, excluding Baltimore City unless 11 expressly designated.
- 12 (e)] "District" means a soil conservation district, a political subdivision of the State continued in accordance with the provisions of this subtitle.
- [(f)] (E) (1) "Due notice" means notice published at least twice, with an interval of at least seven days between the two publication dates, in a newspaper or other publication of general circulation within the appropriate area.
- 17 **(2)** If no publication of general circulation is available, the notice may be posted at a reasonable number of conspicuous places within the appropriate area, including 19 if possible, public places where it is customary to post notices concerning county or 20 municipal affairs generally.
- 21 (3) At any hearing held pursuant to the notice, at the time and place designated in the notice, adjournment may be made without renewing notice for the adjourned dates.
- [(g)] **(F)** "Land occupier" means any person holding title to or possessing any lands lying within a district, whether as owner, lessee, tenant, or otherwise.

- 28 (b) **(1)** The Secretary shall appoint the soil conservation district supervisors 29 from recommendations submitted by the district supervisors of each area represented.
- 30 (2) Each supervisor shall be from one of the following five geographic areas:

16 17 18 19	(c) (1) [The] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, THE supervisors shall be appointed in the following manner, and consideration shall be given to representation from farming, forestry, wildlife, and urban interests where appropriate:
20 21 22 23	[(1)] (I) One district resident by the county governing body and serving at the pleasure of the county governing body[. In], PROVIDED THAT IN those counties with both an executive and a legislative branch of government, the appointment shall be made by the executive and approved by the legislative branch;
24 25	[(2)] (II) One by the Committee from a list of three district residents submitted by the county farm bureau;
26 27	[(3)] (III) One by the Committee from a list of three district residents submitted by the county extension service; and
28	[(4)] (IV) Two by the Committee from among residents of the district.

- 1 (2) THE SUPERVISORS FOR THE BALTIMORE CITY SOIL 2 CONSERVATION DISTRICT SHALL BE APPOINTED IN THE FOLLOWING MANNER, AND 3 CONSIDERATION SHALL BE GIVEN TO REPRESENTATION FROM FARMING, 4 FORESTRY, WILDLIFE, AND URBAN INTERESTS WHERE APPROPRIATE:
- 5 (I) THREE DISTRICT RESIDENTS BY THE MAYOR, SUBJECT TO 6 THE APPROVAL OF THE CITY COUNCIL;
- 7 (II) ONE BY THE BALTIMORE CITY SENATE DELEGATION TO 8 THE GENERAL ASSEMBLY; AND
- 9 (III) ONE BY THE BALTIMORE CITY HOUSE DELEGATION TO THE 10 GENERAL ASSEMBLY.
- 11 (d) **(1)** The term of office of each Committee appointed member is 5 years.
- 12 **(2)** Each supervisor shall hold office until [his] A successor is appointed and qualifies.
- 14 (3) Vacancies shall be filled for any unexpired term by appointments made 15 in the same manner as for the full term.
- 16 (e) **(1)** The Committee, upon notice and hearing, may remove any supervisor from office for neglect of duty or malfeasance in office. [In addition]
- 18 **(2) SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION**, any supervisor who, during any period of 12 consecutive months, shall fail to attend at least [50 percent] **50%** of all regular meetings of the board of supervisors of the district of which [he] **THE SUPERVISOR** is an appointed member, shall be considered to have resigned and the chairman of the board of supervisors shall notify the appropriate appointing body of the resultant vacancy. [However, if]
- 24 (3) IF the reasons for the supervisor's inability to attend meetings as 25 required in this subtitle are found by the appointing body to be satisfactory, the appointing 26 body may reinstate the supervisor to office.

- 28 (a) The General Assembly finds that, from fiscal year 1991 through fiscal year 1998, inadequate resources have been provided for the soil conservation districts to employ adequate field personnel to assist farmers in the preparation of soil conservation and water quality plans.

1 (b) It is the intent of the General Assembly to provide sufficient technical 2 assistance and resources through the soil conservation districts to assist farmers in pursuit 3 of soil conservation and water quality plans and other activities authorized under this title. 4 (c) (1) The Governor shall include in the annual budget bill an amount sufficient to employ not less than 110 field personnel in the soil conservation districts under 5 6 this title. 7 (2) The appropriation for the [24] soil conservation districts shall be as follows: 8 9 (i) For fiscal year 2008, \$8,800,000; 10 For fiscal year 2009, \$9,200,000; (ii) 11 For fiscal year 2010, \$9,600,000; and (iii) 12 (iv) For fiscal year 2011 and each fiscal year thereafter, \$10,000,000.
