- 3 FOR the purpose of prohibiting the State or its reporting agency from entering into certain contracts or plans related to the redevelopment of a certain project at State Center 4 5 unless certain criteria are met; requiring certain criteria to be included in any new 6 or modified plans for the redevelopment of a certain project; requiring the 7 participation of community associations in the process for a certain redevelopment 8 project; providing for the application of this Act; making the provisions of this Act 9 severable; and generally relating to new or modified development plans of a certain project at State Center. 10

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 17 That the Laws of Maryland read as follows:

- 20 (A) THIS SECTION APPLIES TO THE PROJECT DEVELOPMENT OF THE

- 1 PROJECT OR ANY PROPOSED MODIFICATIONS TO EXISTING DEVELOPMENT 2 CONTRACTS FOR THE PROJECT.
- 3 (E) A DEVELOPER WHO IS A PARTY TO A NEW CONTRACT OR PLAN FOR THE
 4 DEVELOPMENT OF STATE CENTER SHALL USE BEST PRACTICAL EFFORTS TO BEGIN
 5 CONSTRUCTION WITHIN 18 MONTHS AFTER EXECUTION OF THE NEW CONTRACT AND
 6 ANY ASSOCIATED PLANS.

7 SECTION 2. AND BE IT FURTHER ENACTED, That:

- 8 (a) Except as provided in subsection (b) of this section, this Act shall be construed 9 to apply only prospectively and may not be applied or interpreted to have any effect on or 10 application to any contract existing before the effective date of this Act.
- 11 (b) To the extent possible, this Act may be construed to apply to a modification 12 made to a contract existing before the effective date of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That, if any provision of this Act or the application thereof to any person or circumstance is held invalid for any reason in a court of competent jurisdiction, the invalidity does not affect other provisions or any other application of this Act that can be given effect without the invalid provision or application, and for this purpose the provisions of this Act are declared severable.
- SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect 19 October 1, 2018.
