A BILL ENTITLED

1 AN ACT concerning

2 **State Payments of Public School Construction Costs – Remittance of**
3 **Reimbursement to County**

4 FOR the purpose of requiring the State, when the State provides reimbursement of
5 forward-funded public school construction or public school capital improvement
6 projects, to remit the funds to the county government for certain payments;
7 prohibiting the State from remitting reimbursement funds to the county board
8 of education; and generally relating to State payments of public school
9 construction and capital improvement costs.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – Education**

18 5–301.

19 **(H–1) (1) SUBJECT TO THE PROVISIONS OF PARAGRAPHS (2) AND (3) OF**
20 **THIS SUBSECTION, WHEN THE STATE REIMBURSES THE COSTS OF A**
21 **FORWARD-FUNDED PUBLIC SCHOOL CONSTRUCTION OR PUBLIC SCHOOL**
22 **CAPITAL IMPROVEMENT PROJECT, THE STATE SHALL REMIT THE FUNDS TO THE**
23 **COUNTY GOVERNMENT.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(2) THE REIMBURSEMENT FUNDS RECEIVED BY A COUNTY**
2 **GOVERNMENT UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL BE USED**
3 **ONLY FOR REQUIRED PAYMENTS FOR DEBT INCURRED BY THE COUNTY FOR**
4 **PUBLIC SCHOOL CONSTRUCTION OR PUBLIC SCHOOL CAPITAL IMPROVEMENT**
5 **PROJECTS.**

6 **(3) THE STATE MAY NOT REMIT REIMBURSEMENT FUNDS TO THE**
7 **COUNTY BOARD.**

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 June 1, 2011.
