1 AN ACT concerning

Task Force to Study Transportation Access

3 FOR the purpose of establishing the Task Force to Study Transportation Access; stating 4 the purpose of the Task Force; providing for the composition, chair, and staffing of 5 the Task Force; authorizing the Task Force to establish subcommittees; prohibiting 6 a member of the Task Force from receiving certain compensation, but authorizing 7 the reimbursement of certain expenses; requiring the Task Force to study and make 8 recommendations regarding certain matters; requiring the Task Force to report its 9 interim and final findings and recommendations to the Governor and the General 10 Assembly on or before a certain date; defining certain terms; providing for the 11 termination of this Act; and generally relating to the Task Force to Study Transportation Access. 12

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1 2 1, 2019. It shall remain effective for a period of 3 years and, at the end of June 30, 2022, 3 this Act, with no further action required by the General Assembly, shall be abrogated and 4 of no further force and effect.
