5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 6 That the Laws of Maryland read as follows:

7 **Article – Alcoholic Beverages**

8 16–102.

9 This title applies only in Carroll County.

11 (a) A holder of a Class A beer and wine license may sell or provide beer and wine
 12 on Monday through Sunday from 8 a.m. to 11 p.m.

13 (b) (1) A holder of a 6–day ~~or 7–day~~ Class B beer and wine license may sell or
 14 provide beer and wine for on–premises consumption[:

15 (i) on Monday through Saturday from 8 a.m. to 1 a.m. the following
 16 day[; and

17 (ii) on Sunday from 11 a.m. to 1 a.m. the following day].

18 (2) A holder of a 7–day Class B beer and wine license may sell **OR PROVIDE**
 19 beer and wine for ~~ON–OR off–premises~~ **ON–PREMISES** consumption[:

20 (i) on Monday through [Saturday] **SUNDAY** from 8 a.m. to ~~11 p.m.~~
 21 **1 A.M.** the following day[; and

22 (ii) on Sunday from 11 a.m. to 11 p.m.].

23 **(3) A HOLDER OF A 7–DAY CLASS B BEER AND WINE LICENSE MAY**
 24 **SELL BEER AND WINE FOR OFF–PREMISES CONSUMPTION ON MONDAY THROUGH**
 25 **SUNDAY FROM 8 A.M. TO 11 P.M.**

26 (c) A holder of a Class C beer and wine license may sell or provide beer and wine
 27 on Monday through Saturday from 8 a.m. to 1 a.m. the following day.

28 (d) (1) A holder of a 6–day or 7–day Class D beer and wine license may sell or
 29 provide beer and wine on Monday through Saturday from 6 a.m. to midnight.

1 (2) A holder of a 7-day Class D beer and wine license may sell or provide
2 beer and wine on Sunday from [11 a.m.] **8 A.M.** to 11 p.m.

4 (a) A holder of a Class A beer, wine, and liquor license may sell or provide beer,
5 wine, and liquor on Monday through Sunday from 8 a.m. to 11 p.m.

6 (b) A holder of a Class B beer, wine, and liquor license may sell or provide beer,
7 wine, and liquor[:

8 (1)] on Monday through [Saturday] **SUNDAY** from 8 a.m. to 1 a.m. the
9 following day[; and

10 (2) on Sunday from 11 a.m. to 1 a.m. the following day].

11 (c) A holder of a Class C beer, wine, and liquor license may sell or provide beer,
12 wine, and liquor[:

13 (1)] on Monday through [Saturday] **SUNDAY** from 8 a.m. to 1 a.m. the
14 following day[; and

15 (2) on Sunday from 11 a.m. to 1 a.m. the following day].

16 (d) Reserved.

17 (e) A holder of a Class H beer, wine, and liquor license may sell or provide beer,
18 wine, and liquor[:

19 (1)] on Monday through [Saturday] **SUNDAY** from 8 a.m. to 1 a.m. the
20 following day[; and

21 (2) on Sunday from 11 a.m. to 1 a.m. the following day].

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
23 1, 2016.
