1 AN ACT concerning

2 **Electronic Cigarettes – Sale to Minors – Components, Supplies, and**
3 **Enforcement**

4 FOR the purpose of clarifying that the prohibition against selling, distributing, or offering
5 for sale a certain electronic device to a minor that can be used to deliver nicotine
6 includes any component for the device or product used to refill or resupply the device;
7 clarifying that the exception to the prohibition for devices approved by the United
8 States Food and Drug Administration applies only to devices for sale as a certain
9 tobacco cessation product; *changing a violation of the prohibition from a*
10 *misdemeanor to a civil infraction;* ~~changing a violation of the prohibition from a~~
11 ~~misdemeanor to a civil infraction;~~ establishing certain civil penalties; providing that
12 a sworn law enforcement officer, county health officer, or a designee of a county
13 health officer may issue a certain civil citation for a violation of this Act; providing

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

Article – Health – General

24–305.

(a) This section does not apply to a tobacco product that is regulated under Title 16 of the Business Regulation Article.

(b) (1) Except as provided in paragraph (2) of this subsection, a person may not sell, distribute, or offer for sale to a minor an electronic device, **A COMPONENT FOR AN ELECTRONIC DEVICE, OR A PRODUCT USED TO REFILL OR RESUPPLY AN ELECTRONIC DEVICE** that can be used to deliver nicotine to the individual inhaling from the device, including an electronic cigarette, cigar, cigarillo, or pipe.

(2) This subsection does not apply to a nicotine device that contains or delivers nicotine intended for human consumption if the device has been approved by the United States Food and Drug Administration **FOR SALE AS A TOBACCO CESSATION PRODUCT AND IS BEING MARKETED AND SOLD SOLELY FOR THIS PURPOSE.**

(c) A person that violates this section ~~is guilty of a misdemeanor and on conviction~~ is subject to a ~~fine not exceeding \$1,000 for each violation~~ **OR A CIVIL PENALTY OF:**

(1) EXCEPT AS PROVIDED IN ITEM (2) OF THIS SUBSECTION, \$300;
AND

(2) \$500 FOR ANY VIOLATION OCCURRING WITHIN 24 MONTHS AFTER A PREVIOUS VIOLATION.

(d) In a prosecution for a violation of this section, it is a defense that the defendant examined the purchaser's or recipient's driver's license or other valid identification issued

1 by an employer, government unit, or institution of higher education that positively
2 identified the purchaser or recipient as at least 18 years of age.

3 **(E) (1) IN THIS SUBSECTION, “DESIGNEE” MEANS A RETIRED SWORN LAW**
4 **ENFORCEMENT OFFICER EMPLOYED BY A COUNTY HEALTH OFFICER OR AN**
5 **EMPLOYEE OF A LOCAL HEALTH DEPARTMENT TRAINED IN CIVIL ENFORCEMENT.**

13 **(IV) THE AMOUNT OF THE CIVIL PENALTY;**

14 **(V) THE MANNER, LOCATION, AND TIME IN WHICH THE CIVIL**
15 **PENALTY MAY BE PAID;**

16 **(VI) A NOTICE STATING THE PERSON’S RIGHT TO ELECT TO**
17 **STAND TRIAL FOR THE VIOLATION; AND**

18 **(VII) A WARNING THAT FAILURE TO PAY THE CIVIL PENALTY OR**
19 **TO CONTEST LIABILITY IN A TIMELY MANNER IN ACCORDANCE WITH THE CITATION:**

20 **1. IS AN ADMISSION OF LIABILITY; AND**

21 **2. MAY RESULT IN ENTRY OF A DEFAULT JUDGMENT**
22 **THAT MAY INCLUDE THE CIVIL PENALTY, COURT COSTS, AND ADMINISTRATIVE**

25 **HEALTH OFFICER, OR DESIGNEE SHALL RETAIN A COPY OF THE CITATION ISSUED**

27 **~~(4)~~ (5) (I) 1. A PERSON WHO RECEIVES A CITATION FROM A**
28 **COUNTY HEALTH OFFICER OR DESIGNEE UNDER THIS SECTION MAY ELECT TO**
29 **STAND TRIAL FOR THE VIOLATION BY FILING A NOTICE OF INTENTION TO STAND**

1 TRIAL WITH THE COUNTY HEALTH OFFICER OR DESIGNEE AT LEAST 5 DAYS BEFORE
2 THE DATE SET IN THE CITATION FOR THE PAYMENT OF THE CIVIL PENALTY.

3 2. AFTER RECEIVING A NOTICE OF INTENTION TO STAND
4 TRIAL UNDER SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH, THE COUNTY HEALTH
5 OFFICER OR DESIGNEE SHALL FORWARD THE NOTICE AND A COPY OF THE CITATION
6 TO THE DISTRICT COURT.

7 (II) A PERSON WHO RECEIVES A CITATION FROM A SWORN LAW
8 ENFORCEMENT OFFICER UNDER THIS SECTION MAY ELECT TO STAND TRIAL FOR
9 THE VIOLATION BY FILING A NOTICE OF INTENTION TO STAND TRIAL AND A COPY OF
10 THE CITATION WITH THE DISTRICT COURT AT LEAST 5 DAYS BEFORE THE DATE SET
11 IN THE CITATION FOR PAYMENT OF THE CIVIL PENALTY.

12 ~~(5)~~ (6) (I) AFTER RECEIVING A CITATION AND NOTICE UNDER THIS
13 SECTION, THE DISTRICT COURT SHALL SCHEDULE THE CASE FOR TRIAL AND
14 NOTIFY THE DEFENDANT OF THE TRIAL DATE.

15 (II) IN A PROCEEDING BEFORE THE DISTRICT COURT, A
16 VIOLATION OF THIS SECTION SHALL BE PROSECUTED IN THE SAME MANNER AND TO
17 THE SAME EXTENT AS A MUNICIPAL INFRACTION UNDER §§ 6-108 THROUGH 6-115
18 OF THE LOCAL GOVERNMENT ARTICLE.
