- (e) (1) In a civil action in which the amount in controversy does not exceed [\$15,000] **\$30,000**, exclusive of attorney's fees if attorney's fees are recoverable by law or contract, a party may not demand a jury trial pursuant to the Maryland Rules.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act may not be construed to affect any requirement under Maryland Rule 2–325 for withdrawal of an election for jury trial after a party may not demand a jury trial pursuant to the Maryland Rules.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or

1 application to any civil action filed before the effective date of this Act.

SECTION 4. AND BE IT FURTHER ENACTED, That this Act is contingent on the passage of Chapter ___ (S.B. ___/H.B. ___)(9lr2078) of the Acts of the General Assembly of 2019, a constitutional amendment, and its ratification by the voters of the State.

SECTION 5. AND BE IT FURTHER ENACTED, That, subject to the provisions of Section 4 of this Act, this Act shall take effect on the proclamation of the Governor that the constitutional amendment, having received a majority of the votes cast at the general election, has been adopted by the people of Maryland.
